## 2017-20 Plan Summary

### The Story

Describe the students and community and how the LEA serves them.

Pacific Union serves 393 students in grades Tk-8th grade. The unduplicated population is 90.84%. English learners make up 58.8% of the population. 87.4% of the students are socioeconomically disadvantaged. Pacific Union Elementary School District is a 22 square mile rural district. Pacific Union provides a safe and secure environment for students. The student to device ratio is 1:1 in grades TK-8. Students receive additional educational experience outside the classroom through each two grade level field trips each year. Pacific Union provides opportunities for parent/guardian/community engagement through school functions, i.e., Back to School Night, Literacy Night, Parent-Teacher Conferences, Craft-Extravaganza, Halloween Parade, May Fiesta Celebration, Open House, Oral Interpretation, etc. Pacific Union is a TK-8 school and the following metrics do not apply: A-G, CTE, AP, EAP, High School Dropout, and Graduation Rates.

### LCAP Highlights

Key features of this year's LCAP include: increased campus safety and additional CPR training (Goal 2, Action 2 and 6); increased safe and welcoming P.E./sports spaces (Goal 2, Action 2); increased psychological services to 3 days per week (Goal 2, Action 3); additional support for subgroups with Common Core (Goal 1, Actions 1, 3, and 4); increased involvement with parent/guardians concerning grades, attendance, and behavior (Goal 2, Actions 3, 4, and 5); hiring a full-time music teacher to expand the music program (Goal 2, Action 7); additional experience for students outside

the classroom through field trips (Goal 1, Action 5); full implementation of the Time to Teach behavior intervention program (Goal 2, Action 5), and increased Professional Development for teachers (Goal 1, Action 6).

## Review of Performance

## Greatest Progress

Pacific Union's students have increased performance on state assessments. The percentage of students meeting or exceeding standard has increased by 0.89% in English Language Arts. Additionally the percent of English Learners meeting or exceeding standard at Pacific Union in English Language Arts was higher than the California average for English Learners in all grade levels except 3<sup>rd</sup> and 6<sup>th</sup>. The same is true for Math in all grades except 3<sup>rd</sup>. The data reported to CALPADS last year for English Language Learners was incorrect, but has been corrected. Our internal data source shows 6.3% of English Language Learners met reclassification criteria. Students reading at or above grade level increased 7%. Although the dashboard shows red for Suspension Rate, Pacific Union decreased Suspension Rate 0.34%. With a Status of 2.96% and change of -0.34%, we anticipate a positive shift on the Fall 2018 Dashboard. ADA was maintained at 95%. 100% of students are provided sufficient materials. The LCFF funds provided to Pacific Union to increase and improve services have given Pacific Union's students the opportunities and support necessary to continue to make progress in these areas. Pacific Union will build upon its success by providing additional support for the unduplicated population through summer school, after-school tutoring, and intervention programs; field trips; increased technology; and increased parent involvement.

## Greatest Needs

Although the Fall 2017 Dashboard shows red for suspension rate, Pacific Union decreased suspension rate by 0.34% to a status of 2.96%. So we anticipate a positive shift on the Fall 2018 Dashboard. The decreased suspension rate is due to increased psychological services to 2 days per week during the 2017-2018 school year. For the 2018-2019 school year, Pacific Union will once again increase psychological services, from 2 days per week to 3 days per week, and implement Social and Emotional Learning Curriculum (purchased with MTSS grant funds) school-wide to continue to improve student behavior and decrease suspension rate. The academic indicators for ELA, Math, and English Learners are Orange. To address these needs Pacific Union will continue professional development for teachers/aides in the areas of English Language Arts and Mathematics with a focus on implementing ELD standards into both subjects; as well as add additional classroom aides for intervention. Tk-3 teachers will be implementing Guided Reading, where many intervention strategies will take place. Teachers in grades 4-8 will continue to provide after-school tutoring where academic interventions will continue.

## Increased or Improved services

Pacific Union will provide tutoring, intervention programs (Goal 1, Actions 1 and 4), and psychological services (Goal 2, Action 3) for academics and behavior to increase student achievement and decrease student suspension rate. Increased instructional technology (Goal 3, Action 3) and teacher professional development (Goal 1, Action 6) will provide teachers with the tools and skills necessary to meet the academic needs of the unduplicated population. These increased and improved services are developed to focus on the needs of our unduplicated population and are principally directed towards the unduplicated pupils.

Describe the overall implementation of the actions/services to achieve the articulated goal.

Pacific Union Elementary School implemented all the actions under Goal 1 as stated above. These actions and services were continued from the prior year, therefore making them smoother and more effective this year, since this was the fourth year of implementation. Teachers in grades K-3<sup>rd</sup> began to implement the Benchmark Assessment System (BAS) to assess reading proficiency in the primary grades. Also, Tk-3<sup>rd</sup> teachers learned the process of Guided Reading, and plan to implement for the 2018-2019 school year. These implementations, when in full implementation, will provide more data to assess reading proficiency and move closer to achieving Goal 1.

Describe the overall effectiveness of the actions/services to achieve the articulated goal as measured by the LEA.

Pacific Union Elementary School implemented all the actions under Goal 1 successfully. By continuing to provided services and programs for unduplicated pupils, such as after school tutoring, daily intervention, grade-level field trips, the expected annual measureable outcome for reclassification were met.

Explain material differences between Budgeted Expenditures and Estimated Actual Expenditures.

For Action 6, we over-estimated the amount for Professional Development. The estimate was made before our Professional Development Contract meeting with FCSS Curriculum and Instruction. Pacific Union used less days and focused on ELA/ELD. For action 3 the dollar amount was less than expected because summer school was targeted to meet the needs of K-3 unduplicated pupils only.

The metric for CELDT proficiency changed because the test changed. This was the first administration of the ELPAC Summative Assessment, therefore growth cannot be calculated until Fall 2019. Action 4 will be modified. The number of aides hired will be 3. Action 1 will be modified to include credentialed teachers.

Describe the overall implementation of the actions/services to achieve the articulated goal.

Pacific Union Elementary School implemented all the actions under Goal 2 as stated above. Most actions and services were continued from the prior year, therefore making them smoother and more effective this year. However, the district will be adapting and strengthening the behavior intervention and prevention through funds and training provided by the Multi-tiered System of Support (MTSS) grant.

Describe the overall effectiveness of the actions/services to achieve the articulated goal as measured by the LEA.

Pacific Union decreased Suspension Rate 0.34%. With a Status of 2.96% and change of -0.34%, we anticipate a positive shift on the Fall 2018 Dashboard. Chronic absenteeism and Average Daily attendance were maintained.

Explain material differences between Budgeted Expenditures and Estimated Actual Expenditures.

Action 6 included additional upgrades which increased the total actual expenditures to \$10,000. Since the Behavior Intervention team did not meet as often as planned the actual expenditures for action 5 decreased to \$0. Action 8 was estimated at a larger amount because Pacific Union planned to hire a registered nurse. However, Pacific Union decided to continue the use of an outside agency to retain a full-time registered nurse, which reduced the cost. The estimated actual expenditure for action 3 was more because an out of date estimate was used. The amount for psychological services has been corrected and is reflected in action 3 for the 2018-2019 school year. Most actions and services were continued from the prior year, therefore making them smoother and more effective this year. New instructional technology was added to classrooms and library. Kindergarten received new chromebooks. New furniture was added to Tk-6 classrooms.

Additional technology and new furniture contributed to a positive school climate and an increase in the 21<sup>st</sup> century learning environment. 100% of teachers are properly credentialed.

For action 1, the amount was more than budgeted by \$22,000 because the cost of materials was more than originally estimated. There was an increase in actual expenditures for actions 3 and 4. The price of the furniture upgrades and instructional technology upgrades was more than expected. Every classroom received new doc cams, mounted projectors, and speakers, which fulfilled action 3. For action 4, all classrooms (Tk-6) received new student desks and chairs, book storage, small group instruction tables and chairs, flexible seating, locking podiums for technology items, and teacher chairs for group instruction. More items were purchased than originally estimated in order to improve the overall learning environment and meet the needs of our unduplicated population, who otherwise do not have access to 21<sup>st</sup> century learning environments. Action 2 was estimated at a higher amount because we expected to purchase Social Studies/History curriculum before July 2018. However, all Social Studies/History curriculum was purchased after July 2018.

- B. How the programs and services will enable English learners to access the CCSS and the ELD standards for purposes of gaining academic content knowledge and English language proficiency.

## **Priority 3: Parental Involvement** addresses:

- A. The efforts the school district makes to seek parent input in making decisions for the school district and each individual school site;
- B. How the school district will promote parental participation in programs for unduplicated pupils; and
- C. How the school district will promote parental participation in programs for individuals with exceptional needs.

## **Priority 4: Pupil Achievement** as measured by all of the following, as applicable:

- A. Statewide assessments;
- B. The Academic Performance Index;
- C. The percentage of pupils who have successfully completed courses that satisfy University of California (UC) or California State University (CSU) entrance requirements, or programs of study that align with state board approved career technical educational standards and framework;
- D. The percentage of English learner pupils who make progress toward English proficiency as measured by the California English Language Development Test (CELDT);
- E. The English learner reclassification rate;
- F. The percentage of pupils who have passed an advanced placement examination with a score of 3 or higher; and
- G. The percentage of pupils who participate in, and demonstrate college preparedness pursuant to, the Early Assessment Program, or any subsequent assessment of college preparedness.

## **Priority 5: Pupil Engagement** as measured by all of the following, as applicable:

- A. School attendance rates;
- B. Chronic absenteeism rates;
- C. Middle school dropout rates;
- D. High school dropout rates; and

- E. High school graduation rates;

**Priority 6: School Climate** as measured by all of the following, as applicable:

- A. Pupil suspension rates;
- B. Pupil expulsion rates; and
- C. Other local measures, including surveys of pupils, parents, and teachers on the sense of safety and school connectedness.

**Priority 7: Course Access** addresses the extent to which pupils have access to and are enrolled in:

- A. A broad course of study including courses described under *EC* sections 51210 and 51220(a)-(i), as applicable;
- B. Programs and services developed and provided to unduplicated pupils; and
- C. Programs and services developed and provided to individuals with exceptional needs.

**Priority 8: Pupil Outcomes** addresses pupil outcomes, if available, for courses described under *EC* sections 51210 and 51220(a)-(i), as applicable.

**Priority 9: Coordination of Instruction of Expelled Pupils (COE Only)** addresses how the county superintendent of schools will coordinate instruction of expelled pupils.

**Priority 10. Coordination of Services for Foster Youth (COE Only)** addresses how the county superintendent of schools will coordinate services for foster children, including:

- A. Working with the county child welfare agency to minimize changes in school placement
- B. Providing education-related information to the county child welfare agency to assist in the delivery of services to foster children, including educational status and progress information that is required to be included in court reports;
- C. Responding to requests from the juvenile court for information and working with the juvenile court to ensure the delivery and coordination of necessary educational services; and
- D. Establishing a mechanism for the efficient expeditious transfer of health and education records and the health and education passport.

**Local Priorities** address:

- A. Local priority goals; and
- B. Methods for measuring progress toward local goals.

# **APPENDIX A: PRIORITIES 5 AND 6 RATE CALCULATION INSTRUCTIONS**

For the purposes of completing the LCAP in reference to the state priorities under *EC* sections 52060 and 52066, as applicable to type of LEA, the following shall apply:

(a) "Chronic absenteeism rate" shall be calculated as follows:

(1) The number of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 – June 30) who are chronically absent where "chronic absentee" means a pupil who is absent 10 percent or more of the schooldays in the school year when the total number of days a pupil is absent is divided by the total number of days the pupil is enrolled and school was actually taught in the total number of days the pupil is enrolled and school was actually taught in the regular day schools of the district, exclusive of Saturdays and Sundays.

(2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 – June 30).

(3) Divide (1) by (2).

(b) "Middle School dropout rate" shall be calculated as set forth in 5 CCR Section 1039.1.

(c) "High school dropout rate" shall be calculated as follows:

(1) The number of cohort members who dropout by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.

(2) The total number of cohort members.

(3) Divide (1) by (2).

(d) "High school graduation rate" shall be calculated as follows:

(1) The number of cohort members who earned a regular high school diploma [or earned an adult education high school diploma or passed the California High School Proficiency Exam] by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.

(2) The total number of cohort members.

(3) Divide (1) by (2).

(e) "Suspension rate" shall be calculated as follows:

(1) The unduplicated count of pupils involved in one or more incidents for which the pupil was suspended during the academic year (July 1 – June 30).

(2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 – June 30).

(3) Divide (1) by (2).

(f) "Expulsion rate" shall be calculated as follows:

- (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was expelled during the academic year (July 1 – June 30).
- (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 – June 30).
- (3) Divide (1) by (2).

- 3) How have the actions/services addressed the identified needs and goals of specific school sites and were these actions/services effective in achieving the desired outcomes?
- 4) What information (e.g., quantitative and qualitative data/metrics) was examined to review progress toward goals in the annual update?
- 5) What progress has been achieved toward the goal and expected measurable outcome(s)? How effective were the actions and services in making progress toward the goal? What changes to goals, actions, services, and expenditures are being made in the LCAP as a result of the review of progress and assessment of the effectiveness of the actions and services?
- 6) What differences are there between budgeted expenditures and estimated actual annual expenditures? What were the reasons for any differences?
