

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).




This chart shows the total general purpose revenue Big Picture Educational Academy expects to receive in the coming year from all sources.

The total revenue projected for Big Picture Educational Academy is \$8,940,799.29, of which \$7,257,159.00 is Local Control Funding Formula (LCFF) funds, \$759,076.25 is other state funds, \$384,334.04 is local funds, and \$540,230.00 is federal funds. Of the \$540,230.00 in federal funds, \$143,808.00 are federal CARES Act funds. Of the \$7,257,159.00 in LCFF Funds, \$1,627,963.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much Big Picture Educational Academy plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Big Picture Educational Academy plans to spend \$8,938,185.00 for the 2020-2021 school year. Of that amount, \$1,827,000.00 is tied to actions/services in the Learning Continuity Plan and \$7,111,185.00 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:


The Learning Continuity Plan does not include the salaries of all our teaching staff, administrators or our facilities costs, which represent the majority of the differences between the General Fund Budget and the total budgeted in the Learning Continuity Plan.

In 2020-2021, Big Picture Educational Academy is projecting it will receive \$1,627,963.00 based on the enrollment of foster youth, English learner, and low-income students.
