





Aspen Meadow Public School is a single direct funded charter school that has experienced a decline in student enrollment of 27 students. Aspen Meadow Public School will use the additional LCFF Concentration grant add-on funds to retain its teachers, and fund additional Instructional Aides to maintain continuity of services, which provide direct services to students specifically Unduplicated Pupils. Despite a decline in student enrollment for the 2021-22 school year, Aspen Meadow Public School maintained higher staffing levels to address the academic needs of its students, and address the impact of lost instructional time, rather than layoff teachers.

Aspen Meadow Public School's considers the LCAP as a comprehensive plan that aligns to the 8 State Priorities, with goals and actions focused on ameliorating student outcomes. Therefore, the engagement and input of educational partners, on the fiscal resources and use of one-time funds that Aspen Meadow Public School has received, has taken place with the LCAP in mind, using multiple forms of data to identify student needs and make informed decisions that are impactful and in alignment with our LCAP.

With the significant decline in student enrollment in combination with increased chronic absenteeism due to COVID-19 surges and protocols, the additional funds are being used to supplement actions in the 2021-22 LCAP to prevent staff (certificated & classified) layoffs that provide direct services to our students and ensure the academic needs of our students are met.

Aspen Meadow Public School has implemented a multitude of evidence-based interventions to address the impact of lost instructional time and accelerate student learning in alignment with the Safe Return to In-Person Instruction and Continuity of Services plan.

Although ESSER III funds are not being utilized in the 2021-22 school year, actions and services will align to the school's LCAP to address and further support student needs.

Aspen Meadow Public School has experienced a decline in student enrollment impacting the school's budget, and fiscal resources are being used to ensure continuity of services and avoid disruptions in learning for all students.

Plan Summary 2022-23

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Aspen Meadow Public School was established in 2016 serving the community in grades TK-2. Since then, the school has expanded and currently serves 270 students in grades TK-6 with student demographics that reflect the community - 76% Hispanic, 7% White, 9% African American, 4% Asian, 3% 2+ Races, of which 13% Students with Disabilities (SWD), 22% English Learners, 1% Foster Youth, 7% Homeless, and 79% Socioeconomically Disadvantaged.

The mission of Aspen is to transform the community by developing exceptional leaders, and our vision leads to greater quality of life for all people in Fresno, regardless of race or economic status. Aspen is focused on the promise of equal educational opportunity for all children. With its college-preparatory focus, the Aspen approach is attaining academic gains throughout the network.

Aspen's approach to teaching and learning enables every student to succeed at the highest levels. This involves:

- Recruiting and developing successful teachers and school leaders who strategically use student data to drive instruction and leadership development.
- Creating a school culture where joy and belonging mark the student experience, with an emphasis on developing leadership that focuses students on college and their futures.
- Providing students with grade-level curriculum, a facilitated learning environment that demands more student cognitive lift, and intense intervention when they are struggling, so that every child has a path to success.

We envision a greater quality of life in Fresno where all families have access to opportunities and contribute to their communities.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The 2021-22 school year marks the return to fully in-person instruction since the start of the pandemic in March 2020.

Aspen Meadow Public School has accomplished the following successes in the past year which include:

Implementation of Second Step SEL Curriculum daily in grades TK-6. It was selected to address skill gaps in student behavior and reduce behavior referrals. The anti-bullying unit was presented in classroom lessons, activities to promote student engagement followed by a school assembly. Second Step requires students to practice social-emotional skills throughout the day, in order to learn to understand emotions and how to cope with daily challenges. The research-based resources offered through Second Step empower our students to thrive at school, at home and in their daily lives. Lessons take place daily and require student participation to cultivate community, gratitude, and self-regulation.

Second Step aligns to our PBIS Pillars – Be Safe, Be Responsible, Be Ready to Learn, and Be Respectful. Second Step has been highly successful in decreasing behavior incidents. Students were recently surveyed on school safety:

- When asked "how well are you doing at school? Are you learning?" 93% responded they were doing very good/good.
- "Do you feel safe in your classroom?" 93% stated that they always/mostly feel safe
- "Do you feel safe outside in the playground?" 97% responded "always or sometimes.
- Approximately 90% responded that they have "good feelings" about their teacher.

Family Circle: Aspen Meadow Public School has implemented weekly family circles on Fridays to celebrate students who have earned PBIS rewards for adhering to the PBIS Pillars. Each week the class with the highest attendance rate receives "Mr. Owl" – a high honor earned for their classroom.

Addition of a Counselor: Due to a significant increase in student SEL needs, including behavioral issues due to lack of socialization, social isolation due to the pandemic. The counselor provided whole-class training and addressed behavior referrals with staff and parents. In addition, the Counselor also observes and monitors student behaviors in unstructured areas such as the playground; and provides small group counseling for students with challenging behavioral issues.

i-Ready: This is the first year of implementing i-Ready assessments, a transition from NWEA MAP assessments. The State Board of Education (SBE) has approved Curriculum Associates i-Ready Assessments as a verified data source. I-Ready is a comprehensive assessment and instruction program that empowers educators with the resources they need to help all students succeed. By connecting

Diagnostic data and Personalized Instruction, i Ready reduces complexity, saves educators time, and makes differentiated instruction achievable in every classroom for each student. i-Ready provides user-friendly dashboards and reports with actionable data that provides teachers with a foundational understanding of each student's strengths and areas of need. I-Ready's online lessons provide tailored instruction and practice for each student to accelerate growth.

Reading was a priority with professional development led by the ELA Instructional coach for our entire teaching staff and Instructional Aides, on strategies to support our struggling readers and the use of remediation guides in the Core Knowledge curriculum. Teachers were provided with pacing guides which included lessons and assessment implementation and timeline. The ELA Instructional Coach also designed data spreadsheets to track student progress which guided our professional learning meetings and trainings as we reflected on what worked and areas for growth.

The Site Director met regularly with the Math Instructional Coach and Achievement First Navigator Math Instructional Coach to discuss teacher instructional practices and identify instructional and professional development needs.

Teacher retention rates were 92% this past year which we attribute to the high levels of teacher support provided through academic coaching in ELA & Math; a highly collaborative Special Education Team, that includes support with student behaviors led by administrators and counselor, in combination with supporting a positive school climate.

Instructional Aides were strategically placed to provide tiered academic support, implement restorative practices/discipline. They also participated in training to improve their intervention practices, restorative discipline, and trauma informed practices.

The **Arts Program** led by the Art Director included community partners that provided guest appearances and readings: Maia Gonzalez, The Elote Man Goes to College and Dorina Lazo Gilmore, Cora Cooks Pancit), and performances from African Drummers and Ballet Folklorico. This cultivated a learning about other cultures and professions/careers/hobbies that a person can have.

Our students participated in a **Jog-a-thon fundraiser** for field trips and guest speakers. The event brought together families and the community.

Student Leadership (**Student Lighthouse Team**) resumed this year. They chose to host a canned food drive for the school's pantry, which was a competitive event, bringing about community, empathy, and the sense of giving.

Each semester we hosted a **Growth Awards Assembly** to recognize students that demonstrated significant growth in reading and math as measured by i-Ready. This event also resulted in student engagement, and ownership of their learning, since students were able to track their performance and growth.



Performance levels for Suspension Rate reflected an orange performance level schoolwide and for Socioeconomically Disadvantaged and Hispanic student group, with a blue performance level for English Learners. For Chronic absenteeism, the school received an orange performance level schoolwide and for the Hispanic student group, with a red performance level for Socioeconomically Disadvantaged student groups.

With the return to in-person instruction, we identified pervasive needs, where students lacked social skills resulting from virtual learning since March 2020. For example, they lacked routines, and socialization. There was a need to adjust instruction, emphasize systems and routines, and how to teach and re-teach due to a lack of continuity of instruction.

i-Ready assessment findings were analyzed and presented to staff and parents; used to inform instruction, identify intervention needs; and use of supplemental instructional materials. These findings were also used in our needs assessment and consultation with our educational partners with the development of the 2022-23 LCAP. There is a significant need to strengthen and expand reading intervention to reduce achievement gaps among Unduplicated pupils.





For the 2022-23 school year, the Math Instructional Coach will continue to train teachers on areas for growth. Students in grades 3-6 will also be assessed using IAB's.

The identified needs based on local performance data and internal schoolwide/student data includes:

- Decline in attendance rates (ADA) – Preliminary 87.9%. We disaggregated attendance rates by grade level to identify trends and needs. An analysis of absences revealed they were predominately due to the school's strict COVID-19 Safety Plan – in adherence to state and county health department guidelines, modified quarantines, infection rates, and fear from families that were impacted by the pandemic.

For the 2022-23 school year the focus will be on strengthening PBIS, hiring an intervention teacher, developing strategies to increase parent engagement and participation; and revise our safety plan to adhere to most recent COVID-19 protocols.



- Internet Safety and awareness: there has been an increase in the number of occurrences of bullying and behavior incidents due to social media challenges on TikTok and Instagram. To address these incidents, the Site Director, School Resource Officer, Counselor, and therapists from All4Youth collaborated and led parent education workshops on strategies to implement including intervening to prevent a serious incident to take place.
- **EL Achievement Gap**: A comparison of i-Ready Fall to Spring performance, demonstrates EL growth in math and reading. In math, EL students advanced from 0% on grade level or above grade level, to 13% on grade level or above grade level. In reading, EL students advanced from 5% on grade level or above grade level, to 21% on grade level or above grade level. While demonstrated growth is evident, there are clear achievement gaps. To address these concerns, our staff has held meetings with parents of ELs, to inform them of the ELPAC assessment, interpret i-Ready assessments and will continue to provide EL with extended learning opportunities through summer school, winter intercession, implement Rosetta Stone supplemental intervention for newcomers, and tutors to provide interpreter services for native Arabic speaking students, to support students with English language acquisition and proficiency.


Fall 2021- i-Ready Reading results: EL vs EO comparison




Spring 2022 – i-Ready Reading results: EL vs EO comparison

During our staff-wide end of year meeting we reflected in the following areas of focus: Academics, Professional Development, School Climate, and culture with our educational partners which influenced the development of the 2022-23 LCAP goals, actions, metrics and services.

LCAP Highlights

A brief overview of the LCAP, including any key features that should be emphasized.

Aspen Meadow Public School continues to expand and strengthen its Multi-tiered System of Supports (MTSS). MTSS is a systemic, continuous-improvement framework in which data-based problem solving and decision-making is practiced across all levels of the school's system for supporting students. This comprehensive framework focuses on the Common Core Sate Standards, core instruction, differentiated learning, student-centered learning, individualized student needs and the alignment of systems necessary for all students' academic, behavioral, and social success. MTSS has a broader scope than does Response to Intervention (Rtl), because MTSS includes focusing on aligning the entire system of initiatives, supports, and resources and systematically addressing support for all students, including gifted and high achievers.

MTSS enables a paradigm shift for providing support and setting higher expectations for all students through intentional design and redesign of integrated services and supports, rather than selection for few components of Rtl and intensive interventions. It endorses Universal Design for Learning Instructional strategies, so all students have opportunities for learning through differentiated content, processes, and product. MTSS integrates instructional and intervention support so that systemic changes are sustainable and based on the Common Core State Standards aligned classroom instruction.

MTSS is a framework that brings together both RtI² and PBIS and aligns their supports to serve the whole child, it also relies on data gathering through universal screening, data-driven decision making, and problem-solving teams, and focuses on content standards. MTSS aligns the entire system of initiatives, supports, and resources, and implements continuous improvement processes throughout the system.

Rtl is an approach that focuses on individual students who are struggling academically and pulls together resources from the LEA, school, and community to promote students' success before they fall behind. It is systematic and data-driven with tiered levels of intervention to benefit every student.

PBIS is an approach that focuses on the emotional and behavioral learning of students, which leads to an increase in engagement and a decrease in problematic behavior over time. It assists the LEA in adopting and organizing evidence-based behavioral interventions that improve social and emotional behavior outcomes for all students.

The 2022-23 LCAP Goals were revised to reflect a "whole child approach" through an equity lens, as we reassessed schoolwide priorities with the return to in-person instruction (post-pandemic) which include:

- Goal #1: Using a whole child approach continue to strengthen and expand schoolwide MTSS and PBIS to ensure the academic, social-emotional, behavioral, and mental health needs of all students are met. Continue to expand partnerships that support our shift to a Community School and ensure all students are College & Career Ready.
- Goal #2: Continue to provide evidence-based professional learning opportunities for all educators, instructional support staff and administrators to build capacity, support teacher retention, to address the diverse learning needs of our students.

- Goal #3: Continue to partner with parents to cultivate a consistent home-to-school relationship, providing multiple opportunities for engagement and input in decision-making in schoolwide program and initiatives. Engage families and students through the implementation of effective strategies that promote a positive school climate, and school safety through ongoing communication.

Engagement of our educational partners has been an ongoing process throughout the academic school year with the development of the multitude of school plans as outlined in the LCAP supplement.

- **Teachers** met weekly (Friday) in-person & virtual staff meetings and discussions took place on COVID-19 protocols, i-Ready data analysis, intervention groups, MTSS leveled supports, SEL/PBIS implementation. Teachers were also surveyed; and participated in a Climate and Culture end of year meeting to reflect on strengths and needs, and use of one-time funds.
- **Principals & Administrators** met weekly to discuss COVID-19 protocols, attendance/absenteeism, behavioral issues, data, LCAP updates, use of one-time funds (AB 130/ESSER III), 2022-23 LCAP Planning, staffing, professional development needs, and interventions.
- **Other School Personnel** met in-person on a bi-weekly basis to discuss attendance and absenteeism rates, communication with families, planning schoolwide events, use of one-time funds, and COVID-19 protocols
- Parents including those representing Unduplicated Pupils (UP) and Students with Disabilities (SWD): were surveyed as part of the consultation process on the use of ESSER III Funds and one-time funds. (October 2021, February 2022)
- **Students including Unduplicated Pupils and Students with Disabilities (SWD)** discussions took place in-person weekly during family circle; and assemblies on SEL, Second Step, bullying, assessments, and the PBIS pillars. A student climate survey was also administered, which included use of one-time funds.
- **SELPA** The Director of Special Education Director and members of the SPED team met virtually on a monthly basis to discuss professional learning opportunities, fiscal and program updates, and LCAP action/goal (as part of the consultation process). AMPS is in compliance with IEPs held on time and 100% parent participation in IEP meetings. Parents of Students with Disabilities (SWD) are included in all parent events, workshops, surveys and climate surveys.
- **ELAC/DELAC and EL-PAC:** meeting took place virtually on 10/27/21 and were surveyed. Discussions took place on reclassification rates, ELPAC assessments, EL student performance on SBAC and i-Ready, and use of one-time funds.
- **Parent Advisory Committee (PAC) including parents of UP and SWD** meetings took place virtually on 10/6/21 and 2/17/22 and discussed the ESSER III Plan: and use of one-time funds, prioritizing schoolwide needs, and COVID-19 policies

A summary of the feedback provided by specific educational partners.

The following is a summary of the feedback provided by the following required educational partners, that emerged from an analysis of the input received in the development of the 2022-23 LCAP.

- **Teachers** would like additional time for planning intervention; requested professional development on the reading program (Track lexile), writing, Second Step, Trauma Informed Practices, Summit Learning and how to identify human trafficking.
- Principals/ Administrators would like to provide professional development for teachers on implementing daily formative assessments.
- **Other School Personnel** requested the need for summers school, Instructional Aides to support students in the classroom, and a health aide.
- Parents including those representing Unduplicated Pupils (UP) and Students with Disabilities (SWD): were concerned with learning loss arising from remote learning and would like Instructional Aides in every classroom to provide additional academic support, full-time nurse, and full-time counselor to provide SEL, counseling services, and ensure needs of homeless/foster youth are met (resources).
- **Students including Unduplicated Pupils and Students with Disabilities (SWD)** would like to continue with Family Circles, schoolwide events, and assemblies.
- SELPA no additional feedback was provided regarding LCAP & actions
- **ELAC/DELAC and EL-PAC** were concerned with the academic needs of ELs and would like Instructional Aides to support ELs with English language proficiency and learn about strategies to support their child at home. Parents also requested after-school tutoring since many families expressed that no one in their household speaks fluent English.
- **Parent Advisory Committee (PAC) including parents of UP and SWD:** requested summer school, and Instructional Aides during the school year, health aides, new laptops for students, full-time psychologist, Special Education tutors, and funds to support professional development for teachers and staff.

Action 1: The Assistant Site Director position became vacant in mid-September 2021, and the position remains vacant due to a lack of qualified applicants.

Action 1: as a result of the vacant Assistant Site Director position, there is a material difference between Budgeted Expenditures and Estimated Actual Expenditures.

An explanation of how effective the specific actions were in making progress toward the goal.

Mathematics Navigator is a highly flexible intervention program that addresses learning gaps by building conceptual understanding, problem-solving, and skills, providing Tier 2 intervention and supporting English Learners and Students with Disabilities. AMPS employs Instructional Aides (one in each classroom) to provide evidence-based high-dosage tutoring for students struggling academically as a result of the impact of lost instructional time. Teachers participated in summer professional learning on Navigator math, Summit learning, Second Step and PBIS which was highly effective in meet the LCAP goal and to prepare for the return to inperson instruction. The ELA, Math, and Summit Coach provided ongoing instructional coaching for teacher to address the diverse learning needs of students and improve student outcomes.

Aspen Meadow students were mainstreamed to the greatest extent possible and IEP teams consider the unique needs when determining the most appropriate method of instruction and placements throughout the continuum. Aspen Meadow hired additional support staff, special education instructional aides, a speech and language pathologist assistant, and a full-time counselor to provide additional intensive instruction to address the impact of lost instructional time and to provide social-emotional support due to the pandemic.

Students with Disabilities (SWD) were provided services in the Learning Lab, speech room, or counseling office to receive targeted, individualized instruction or additional curriculum resources to meet their needs. With the return to in-person instruction and as part of our annual comprehensive needs assessment through the analysis of i-Ready assessment data, schoolwide/student group data, we identified academic achievement gaps among Unduplicated Pupils.

Consistent with the requirements of 5 CCR Section 15496(b), increased services that are contributing for Unduplicated Pupils (UP); and are principally directed towards and effective in meeting the academic needs of Unduplicated Pupils (UP) and are provided on a schoolwide basis which include:

- Goal 1, Action 1: To assess learning gaps, monitor student progress and develop annual growth targets, inform instruction, the following assessments will be administered and utilized as part of the MTSS process: i-Ready Reading & Math and ESGI assessment (Goal 1, Action 1). Through the use of this universal screener, we will be able to measure, and monitor student group performance, identify growths and needs to provide evidence-based interventions; and develop annual growth targets.
- Goal 1, Action 2: An area of concern is student academic performance in ELA and Math; and the achievement gap among Unduplicated pupils (UP) and Students with Disabilities (SWD) compared with overall schoolwide performance. The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- Meaningful Engagement of Educational Partners: The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Goals and Actions

Purpose

Well-developed goals will clearly communicate to educational partners what the LEA plans to accomplish, what the LEA plans to do in order to accomplish the goal, and how the LEA will know when it has accomplished the goal. A goal statement, associated metrics and expected outcomes, and the actions included in the goal should be in alignment.  - o This amount is the total of the Estimated Actual Percentage of Improved Services column
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)

 This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8)

LCFF Carryover Table

 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
 - o If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
