WHEREAS, Arts Education, which includes dance, media arts, music, theatre, and visual arts, is an essential part of basic education for all students, pre-kindergarten through grade twelve, to provide for balanced learning and to develop the full potential of their minds;

WHEREAS, through well-planned instruction and activities in the arts, children develop initiative, creative ability, self-expression, self-reflection, thinking skills, discipline, greater social emotional well-being, a heightened appreciation of beauty, and cross-cultural understanding;

WHEREAS, experience in the arts develops insights and abilities central to the experience of life, and the arts are collectively a most important repositories of culture;

WHEREAS, many national and state professional arts education associations hold celebrations in the month of March, focused on students' participation in the arts;

WHEREAS, these celebrations give California schools a unique opportunity to focus on the value of the arts for all students, to foster cross-cultural understanding, to give recognition to the state's outstanding young artists, to focus on careers in the arts available to California students, and to enhance public support for this important part of our curriculum;


WHEREAS, the California State Board of Education states in its Arts Education Policy adopted in July 1989 that each student should receive a high quality, comprehensive arts education program based on the adopted California Arts Framework for California Public Schools, Pre-Kindergarten through Grade Twelve (2020);




