The text description for the above chart is as follows: The total revenue projected for Kings Canyon Joint Unified School District is \$185,468,022, of which \$142,110,728 is Local Control Funding Formula (LCFF), \$24,876,659 is other state funds, \$8,784,999 is local funds, and \$9,695,636 is federal funds. Of the \$142,110,728 in LCFF Funds, \$39,534,664 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$183,720,184 is tied to actions/services in the LCAP and \$18,480,503 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

Federal funds that are site specific were not included in the Local Control and Accountability Plan (Title I Site Allocations per the Consolidated Application are included in individual site School Plans for Student Achievement). Additionally, federal and state COVID-19 relief "one time" funds were not included in the LCAP. KCUSD included only ongoing actions as part of the District's strategic action plan to serve students through this LCAP.

In 2023-24, Kings Canyon Joint Unified School District is projecting it will receive \$39,534,664 based on the enrollment of foster youth, English learner, and low-income students. # Plan Summary [2023-24]

### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Kings Canyon Joint Unified School District (KCUSD) is a preschool through 12th grade public school system that serves students from a 600 square-mile area, one of the largest geographic area school districts in California.

Diverse in geography and culture, KCUSD serves the cities of Reedley, Orange Cove and the foothill and mountain communities of Navelencia, Squaw Valley, Dunlap and Miramonte. KCUSD employs approximately 1,500 staff members and has a student population approaching 10,000.

KCUSD operates 22 school campuses in configurations that include TK-5, TK-8, middle school, high school and adult school. KCUSD offers a robust selection of programs that include preschool education, dual immersion, adult education, alternative education, vocational education and a wide range of special education programs. A middle college and an online academy are also offered to meet a broad spectrum of student needs. Students enjoy stimulating and innovative curricula that align with state standards and effectively target student needs and interests. We partner with Central Valley Regional Center to support KC Kids which provides a family-centered, relationship based early childhood program, supporting families of children 0-3 years old who have special needs as well as special education services for preschoolers 3-5 years old, and an in-home individualized intensive behavioral program for young children with a diagnosis of autism or children who are at risk for autism.

Our student population (2022 California School Dashboard) is 29.9% English Learner, 87.5% are classified as Low Income, and 0.4% as Foster Youth. The percentage of students who are low-income, English learners or foster youth is 87%. Our student population is made up of many ethnicities – 89.9% Hispanic, 7.7% White, 0.5% Asian, 0.2% African American, 0.3% Native American, 0.4% Filipino, and 0.9% two or more races.

KCUSD's mission is to provide a broad spectrum of educational programs and co-curricular activities for all students so that they may attain their highest potential.

The COVID-19 pandemic brought about significant challenges to schools that had to be addressed during the "full" reopening of schools in the 2022-2023 academic year. The greatest challenge was ensuring the health and safety of students, teachers, and staff. This involved implementing safety measures, protocols and facilities improvements to ensure the continued and safe operation of District programs. KCUSD did this by adhering to guidelines and regulations set forth by both state and local health officials and by maintaining strong communication with District and site leaders.

As a result of the COVID-19 pandemic, KCUSD had to address the varying levels of student engagement and academic progress due to extended periods of remote learning. KCUSD has worked diligently to address any potential gaps in learning and has worked to provide an abundance of support to students who may have fallen behind during the pandemic. This included extended learning opportunities during winter and summer breaks, Saturday Academies, tutorials, credit recovery programs and additional support staff at school sites. Because KCUSD was able to fully utilize the 2021 Smarter Balanced Assessment (SBAC), KCUSD was able to measure the impact these supports had by comparing scores to the 2022 SBAC.

In to 2022-2023, KCUSD was able to expand the social and emotional supports available for students. The COVID-19 pandemic had a profound effect on the lives of students, families and the KCUSD community. In addition to the physical health risks posed by the pandemic, social and emotional challenges became far more prevalent. This has resulted in a need for greater social and emotional supports for students to ensure that schools can provide a safe and supportive environment where students can discuss their feelings and experiences with knowledgeable and caring adults who can provide the support needed to help students attain their highest potential. KCUSD incorporated social and emotional learning into the base curriculum across all grade levels and expanded the supports available to students and their families.

Despite the many challenges the staff, students and families of KCUSD have faced, as a District, we continue to make progress and aim to provide a high quality education where students are able to reach their highest potential.

## **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

The areas of success KCUSD has seen through this three year LCAP period truly stem from the decisions made during the pandemic and throughout the 2020-2021 school year. KCUSD was committed to bringing back as many students as was feasibly possible under the guidance established by local, state and federal health officials. KCUSD's philosophy throughout this period was that students would do better when supported in person by qualified, caring adults on a daily basis. The outcomes of those decisions resulted in students returning back to in person instruction ahead of most school districts in the valley truly paid off. This is evidenced by a comparison of the 2022 CAASPP results with those of neighboring districts as well as the growth of KCUSD students when compared to the 2021 CAASPP results.

KCUSD tested close to 95% of eligible students in 2021 (most districts in California did not), which gave KCUSD a unique opportunity to compare academic proficiency and reasonably determine incomplete learning or learning loss for District students.

In 2021, Students in KCUSD showed 43% of "all students" meeting or exceeding standards in ELA and 26% meeting or exceeding standards in Math. With CAASPP testing resuming for the entire state in 2022, having fully tested in 2021 allowed us to compare where our students were and how far they needed to go to get "caught up" following the pandemic. In 2022, KCUSD students saw an overall increase in the percentage of students meeting or exceeding standards of 4.5% in ELA and 7.9% in Math. Additionally, student groups showed significant improvement in the percentage of students meeting or exceeding standards. Female students showed a 3.8% improvement in ELA, while males students saw a 5.2% increase. In Math, female students showed a 7.3% increase in the percentage of students meeting or exceeding standards, while male students improved by 8.5%. Economically disadvantaged students showed an increase of 4.3% in students meeting or exceeding standards in ELA and 8.1% in Math. Students with disabilities showed an improvement of 2.9% in ELA and 3% in Math. English Learners showed an increase of 10% in ELA and 10.5% in Math. Reclassified Fluent English Proficient students showed an increase of 4.4% in ELA and 10.9% in Math. The significant improvement across student groups in addition to the "all students" metric are areas for celebration as it reflects the work of the entire KCUSD community in supporting students so they may all reach their highest potential. KCUSD is definitely on the right track and will continue to improve as California continues to recover from the effects of the COVID-19 pandemic.

In comparison to surrounding districts, KCUSD has historically been among the higher achieving Districts in both Fresno and Tulare Counties. In 2022, KCUSD ranked third among all unified school districts in both Fresno and Tulare Counties for Percent Met or Exceeded in ELA and second in Math. When comparing average distance from standards, KCUSD ranked second among all unified school Districts in both counties in ELA and third in Math. More impressively, when comparing only school districts with similar demographics (Enrollment of over 1000+ and 80%+ economically disadvantaged students) KCUSD ranks one out of fifty-seven similar districts for the percentage of students meeting or exceeding standards and one out of fifty-seven similar districts for average distance from standard.

In 2022, the California School Dashboard reported "status" only reports. KCUSD's received a performance level on the English Learner Progress Indicator (ELPI) of HIGH due to 55% of English Learners making progress on the ELPAC. Had 232 more English Learners made progress, the performance level would have been VERY HIGH. A more detailed breakdown of these performance levels is included in the reflection section for identified needs.

In 2021-2022, KCUSD was able to establish a universal screener to identify areas in which students needed social-emotional supports the most. KCUSD established the use of the DESSA (Devereux Student Strengths Assessment) for students across the District to inform sites on the areas of social-emotional need and to identify specific students in need of Tier 2 and 3 support. This screener, utilized in tandem with Second Step curriculum in grades K-8 and a high school driven curriculum in grades 9-12, allowed KCUSD to deliver greater social-emotional support than in years prior. Beyond the delivery of the Second Step curriculum, KCUSD support staff was able to provide additional services based on the needs identified through the DESSA that otherwise could have potentially gone unnoticed. In support of this increased focus on SEL, KCUSD hired additional school social workers, psychologists, behavior team members and restorative justice counselors to deliver the SEL support students required. Through these additional supports, KCUSD SEL providers are able to see students in small groups, individually and if necessary, refer to Tier III or outside services on a wider scale than in the past. In order to further support

these social-emotional needs, KCUSD staff have been introduced to Trauma Informed Care through collaboration with All 4 Youth service providers and have launched a trainer of trainers cohort to further support the professional development of staff to better prepare adults in KCUSD to support the social-emotional needs of our students. Additionally, SEL lessons were expanded to the KCUSD Expanded Learning Program (formerly Afterschool Program) to ensure an aligned system of supports across the entire District. KCUSD has established its own Restorative Justice program with two experienced coordinators. The Restorative Justice team has been successful in providing support to students resulting in a reduction in the number of students that would have otherwise been suspended, expelled or incarcerated.

## **Reflections: Identified Need**

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

After analysis of the California School Dashboard, "status" only reports KCUSD has been able to identify the areas of greatest need among our student groups based on the six indicators reported. Through this analysis, it is apparent that the student group with the greatest need is the Students with Disabilities group. In 2021-2022, this group's performance level for ELA, Math, graduation rate and chronic absenteeism was very low. For the suspension rate indicator, this student group's performance level was low. Similarly, the Foster Youth student group was also very low for Math, chronic absenteeism and suspension rate. This student group's performance level was low for ELA and did not receive a performance level for graduation rate. Due to the performance level of both of these groups, KCUSD qualified to receive additional support from the Fresno County Superintendent of School's (FCSS) office in the form of Differentiated Assistance. Through this partnership, KCUSD and FCSS will work together to review data and systems to identify potential causes of low performance identified by the Dashboard and then identify next steps. In preparation for this work, KCUSD has conducted in depth studies to determine potential root causes and address gaps as appropriate. Some of the actions taken to support both Students with Disabilities and Foster Youth students include additional staff for prevention and intervention, social-emotional learning, and behavioral supports specifically targeting the gaps identified through the needs assessments. Specific actions are detailed in the Goals and Actions sections of this LCAP. The following is a breakdown student group performance levels on the California Dashboard for ELA, Math, graduation rate, chronic absenteeism and suspension rate.

In the area of English Language Arts Performance, students in the "all students" category averaged 7.7 points below standard. This score assigned KCUSD a performance level of LOW. If the average student scale score were 2.7 points higher, the performance level would have been MEDIUM. White students scored HIGH, students of two or more races scored MEDIUM, while Hispanic/Latino students, English Learners, Socio-economically Disadvantaged students, Homeless Youth, and Foster Youth students scored LOW. Students with Disabilities scored VERY LOW. In the area of Math, students in the "all students" category averaged 46.5 points below standard. This score assigned KCUSD a performance level of LOW. If the average student scale score were 21.5 points higher, the performance level would have been MEDIUM. White students and students of two or more races scored MEDIUM, while Hispanic/Latino students, English Learners, Socio-economically Disadvantaged students, and Foster Youth students scored LOW. Students with Disabilities and Foster Youth students scored VERY LOW. In order to address the discrepancy between the groups listed above, KCUSD has planned to increase and improve services to reduce the achievement gap for these students. KCUSD will increase professional development and concentrate on Professional Learning Communities to address the unique needs of all students, while pinpointing the needs of targeted students. Additionally, KCUSD

will increase supports for students through additional classified and certificated staff while expanding programs such as the School Connections program, Student Transition Program, socio-emotional and academic counseling supports.

For the Graduation Rate Performance Indicator, KCUSD's overall graduation rate was 86.5%. This score assigned KCUSD a performance level of MEDIUM. Had 28 more students in the District graduated, the graduation rate indicator would have been assigned a performance level of HIGH. White students, Hispanic/Latino students and Socioeconomically Disadvantaged students scored a performance level of MEDIUM. English Learners scored a performance level of LOW, while Students with Disabilities scored VERY LOW. As part of the FCSS Differentiated Assistance support work KCUSD has engaged in, KCUSD will review root causes for this discrepancy in achievement as well as utilize collaborative teams to improve outcomes for those students struggling the most. KCUSD will utilize data to make decisions for interventions and utilize additional intervention and literacy teachers to provide additional support to those most at risk of falling behind.

For the Chronic Absenteeism Performance Indicator, students in the "all students" category, 12.4% were classified as chronically absent. This percentage assigned KCUSD a performance level of HIGH. If 162 fewer students had been chronically absent, the performance level would have been MEDIUM. Asian students, Hispanic/Latino students, white students, students of two or more races, English Learners and Socioeconomically Disadvantaged students were classified as HIGH. Students with Disabilities, Homeless Youth and Foster Youth students scored VERY HIGH. Additional counselors, social workers and psychologists will be added to support these issues with the expectation these outcomes will improve. In addition, parent education opportunities will be continued that support parents with tools to support students at home.

For the Suspension Rate Performance Indicator, KCUSD registered a 4.8% for the "all students" category. Had 30 fewer students been suspended, the performance level would have been MEDIUM. English Learners had a performance level of MEDIUM, while Hispanic students, White students, students of Two or More Races, Socioeconomically Disadvantaged students, Students with Disabilities and Homeless Youth were assigned a performance level of HIGH. Foster Youth students received a performance level of VERY HIGH.

## **LCAP Highlights**

The Kings Canyon Joint Unified School District (KCUSD) Local Control and Accountability Plan (LCAP) is organized to address six goals. The following is a brief overview of the components within each of the six goals.

Goal 1: All students will receive a high quality education in an environment designed to provide them with opportunities to develop their greatest potential.

This goal focuses on "basic services," ensuring that students are attending school on campuses that are in good condition while being taught by teachers who are appropriately credentialed and assigned, provided with adequate textbooks, materials and supplies

Goal 2: All students will demonstrate an increase in academic achievement in all core subject areas - ELA, Math, Science, and Social Science - through the implementation of state standards.

This goal focuses on the implementation of state standards ensuring that students have access to grade-level state standards, along with rigorous curriculum and instruction to support academic achievement for all students. Included in this goal are actions that provide necessary structures for progress monitoring, professional development, intervention and enrichment support for student success.

Goal 3: All English learners will demonstrate progress towards attaining English language proficiency and increase the percentage of attaining proficiency in ELA and Math.

This goal focuses on actions designed to ensure that English learners have increased support towards attaining English language proficiency and increasing student achievement on state and local metrics. Included in this goal are actions that provide necessary structures for progress monitoring, professional development, intervention and enrichment support targeted specifically to address the needs of English learners.

Goal 4: All students will be provided a broad spectrum of educational and co-curricular activities so that they may reach their highest potential and their college and career goals.

This goal focuses on the co/extra-curricular activities available for students to help ensure that students are provided a broad spectrum of activities to support college and career readiness. Included in this goal are actions designed specifically to keep students engaged in school activities beyond the core curriculum that support students on their path towards graduation while preparing them for college and careers.

Goal 5: All students will be provided with safe and nurturing learning environments that support their social, emotional, and academic success.

This goal focuses on the school climate, culture and safety, ensuring that students are provided with safe and nurturing learning environments to support their social, emotional, health and academic success. Included in this goal are actions aligned with a District-wide implementation of PBIS structures, school climate and culture supports, social-emotional learning and health related services.

Goal 6: All students will have the opportunity to increase academic achievement through the engagement of parents and families. This goal focuses on parent education and engagement for the purpose of ensuring that parents and families have meaningful and relevant engagement opportunities and experiences with KCUSD and school sites. Included in this goal are actions designed to support communication structures between families and schools while providing educational and engagement activities for parents and caregivers to support student achievement.

### Support for Identified Schools

A description of how the LEA has or will support its eligible schools in developing comprehensive support and improvement plans.

For the purpose of supporting Mountain View School (MVS), KCUSD required that a comprehensive needs assessment be conducted to drive the goals for improvement aligned to the California School Dashboard indicators. This needs assessment was conducted through analysis of data, analysis of the current instructional program, current status of results on performance assessments related to student achievement from local and state assessments, staffing and professional development, alignment of curriculum and instruction and parent engagement. This data was provided to the site through the mining of the student information system data, using the California School Dashboard to identify current reality. Data was presented to the school site through a district wide analysis of all indicators on the California School Dashboard, comparing data from previous year on all indicators. This data was compared to other similar schools and analysis was conducted to determine what movement would have to take place to improve student outcomes. KCUSD District administrators will continue to work with the staff of MVS to identify any resource inequities and provide support. KCUSD assigned a full time administrator to MVS for 2022-2023 who worked with the principal of Educational Options to identify and address any areas that can be strengthened.

The School Site Council (SSC), in partnership with site and District administration reviewed this data together to help guide the development of the School Plan for Student Achievement (SPSA) and incorporated the resources available through the Comprehensive Support and Improvement (CSI) program as well as through other District provided resources in response to the identified needs. Through this needs assessment, it was determined that additional supports are needed to increase graduation rate for MVS students and improve attendance rates. At MVS, credits towards graduation and attendance rates are directly tied to successful completion of assigned independent study curriculum. KCUSD is currently investigating additional ways to support MVS students so they can successfully complete their assigned course work. KCUSD will utilize the Edgenuity platform to provide additional learning opportunities tailored to students' needs and abilities. In order to provide this support, an additional MVS facility was built on the Orange Cove High School campus to increase access to the program for students residing in Orange Cove. Additionally, KCUSD is expanding the facilities at the Reedley MVS campus to allow for greater engagement and participation in school activities. These facilities are expected to be available for students in the fall of 2023-2024 and will allow for greater in-person support of students, facilitate credit recovery and provide academic support which will be required in the delivery of this instructional model.

Additional staffing has been added to MVS in the form of an academic guidance counselor and a learning director specifically assigned to the MVS program. As part of this comprehensive review, MVS also reviewed attendance trends for the school by grade level to identify trends and patterns and enrollment data to identify areas of greatest need. Through this process, it was determined that the school site would need to target chronic absenteeism at the lower grades through earlier intervention. It became clear through this evaluation many of the students at MVS had limited resources at home and as a result had obstacles to attending school or completing their assignments. MVS will continue to utilize the additional technology and staffing to mitigate those obstacles by providing greater 1:1 service opportunities, increased technology and access to the internet for students enrolled in the independent study program.

MVS will receive supplementary funding through the CSI ESSA grant to support improvement in the areas identified through the California School Dashboard (Graduation Rate and Chronic Absenteeism). Kings Canyon Unified School District will collaborate with Mountain View to

draft ongoing plans to support the areas of need identified through the school dashboard and provide additional support in aligning resources to implement the plan.

MVS's SPSA was built to provide evidence-based improvement strategies to support chronic absenteeism and graduation rate. Selection of evidence based intervention included a review of literature, study of meta-analysis and utilizing resources such as the What Works Clearinghouse. When contracting with external providers, KCUSD will only utilize providers who demonstrate research based practices that are in alignment with District goals and objectives in support of student achievement. Once the appropriate department has determined that research based practices indicate potential for a benefit to the students and/or staff of KCUSD, contracts for services will be reviewed and approved by the KCUSD Board of Education.

### Monitoring and Evaluating Effectiveness

A description of how the LEA will monitor and evaluate the plan to support student and school improvement.

During the 2019-2020 school year, KCUSD established an additional monitoring support structure for schools identified for CSI that includes bringing together District leaders, other principals and administrators for the purpose of supporting the implementation of improvement actions. Approximately every month, this group will collaborate with MVS in support of progress monitoring and action plan implementation.

The addition of the academic counselor and learning director assigned directly to MVS will support the effective progress monitoring of the implementation of the CSI/SPSA. Working collaboratively with site and District staff, the primary measurement of the effectiveness of implementation will be an increase in attendance, completion of credits towards graduation and ultimately, an increase in graduation rate for MVS school. The primary goal of the greater 1:1 service opportunities, increased access to technology and internet will be to increase the amount of work completed by all students enrolled at MVS. Students at MVS earn attendance and credits based on the completion of assigned work and are supported by their independent study teacher. Student data will be collected on the increase of work completion (which will also impact attendance for those students) and credits earned.

During these collaborative support meetings, site and District leaders will review attendance trend data, completion of work data and credits earned by Mountain View School students and adjust accordingly based on progress or the absence of progress. This data will be tracked at the site level and reviewed during the monthly collaborative support meetings with any proposed changes to the plan being discussed with the School Site Council.

# **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Kings Canyon Unified School District (KCUSD) used a variety of methods to solicit input from all educational partners. Educational partner groups included parents, teaching staff, support staff, principals, learning directors, District administrators and local bargaining units for both classified and certificated staff. School sites engaged parent groups on the LCAP and solicited input as to how KCUSD could improve the services provided to students. In addition to District meetings and school presentations,KCUSD also distributed annual surveys to all parents, students in grades 3-12 and to all classified and certificated staff members. The surveys were used as tools to collect feedback from educational partners on the actions and goals of the LCAP.

Educational Partner Engagement Process:

Annual LCAP Community Informational Workshops took place on January 26, 2023, and February 2, 2023. Present at these workshops were parents, site administrators, classified and certificated staff in addition to community partners.

KCUSD has traditionally collected an annual Parent Survey. This information is used to help provide a focus for both District and site direction. To gather information from students, KCUSD utilized an annual Student LCAP Survey to help inform the direction of the LCAP from a student perspective. In addition to this parent survey, a community survey specific to the LCAP was also conducted for anyone in the KCUSD community to complete, including parents, teachers, classified staff and community members.

Presentations about LCFF and actions from the LCAP, and LCAP process were shared with the following groups:

District Advisory Committee (Parent Advisory Committee) - October 24, 2022, January 23, 2023, March 6, 2023 and May 8, 2023. Kings Canyon Teachers Association - February 27, 2023 California School Employees Association - April 24, 2023 District English Language Advisory Committee - October 24, 2022, January 23, 2023, March 6, 2023 and May 8, 2023. LCAP Community Survey - Spring, 2023 (Teachers, Classified, Staff, Parents, Community Members) Annual Student LCAP Survey - Spring, 2023 Children's Day LCAP Survey - April 27, 2023 Principals/Administrators - biweekly meetings.

School Site Parent Input:

All school sites requested input from parent groups regarding the Local Control and Accountability Plan. School sites requested feedback and suggestions through their School Site Councils, English Learner Advisory Committees, Puente a Tecnologia programs, Latino Literacy groups and Parent Teacher Clubs.

SELPA Collaboration and Special Education Engagement

Kings Canyon Unified School District is part of the Fresno County SELPA and participated in SELPA Operations meetings, where the LCAP was discussed with member districts and input was solicited from that educational partner group. 2022 - 2023 Operations meetings were held on September 15, 202, October 18, 2022, November 10, 2022, January 26, 2023, February 16, 2023, March 9, 2023, April 20, 2023 and May 8, 2023.

Additionally, KCUSD holds regular Special Education "Parent Connect" meetings to seek input on what KCUSD can do to improve services for special education students. This year, those engagement opportunities took place on September 20, 2022, October 18, 2022, November 15, 2022, February 7, 2023, March 14, 2023 and April 18, 2023.

KCUSD also utilizes a Special Education Cabinet to seek input on how to improve services for Special Education students in KCUSD. This team is comprised of site administrators, special education and general education teachers and District administration.

Board Meetings - May 23, 2023, June 13, 2023 LCAP Proposed Draft actions presented to the District Advisory Committee (Parent Advisory Committee) -(May 8, 2023) and the District English Learner Advisory Committee (May 8, 2023). There were no questions proposed by either advisory council. Public Comment Period - May 12-23, 2023 Local Indicators were presented in conjunction with LCAP as per Ed Code 52062 (b)(2) Board adopted the LEA budget at the same meeting as the LCAP Adoption. Public Hearing - May 23, 2023 Board Approval - June 13, 2023

A summary of the feedback provided by specific educational partners.

Below is a brief summary of the feedback collected from a variety of Educational Partners:

Parent Groups:

Parents continued to provide very positive feedback as to the supports provided for students. Parents shared that they appreciated the twoway communication capabilities of Parent Square. Parents also shared their appreciation for the availability of the expanded learning program (ELP) which is a great support for students and families, especially now that there is no waiting list. Parents also mentioned their support for the inclusion of TK as part of the ELP. Parents expressed a need to increase the supports for social-emotional supports and for students who have behavior issues. Parents would like there to be more support from counselors, social workers, psychologists, campus assistants and caring staff. Parents also asked for continued professional development for teachers and staff to support students socioemotionally. Parents were also interested in seeing an expansion of the offerings in CTE courses, school field trips, athletics, visual and performing arts and other co/extra curricular activities. They felt that CTE classes are good for students, and adding more options will benefit students, especially for those that do not see college as their primary option upon graduation. At the LCAP parent workshops and District Parent Advisory Committee feedback sessions, several parents inquired about expanding the farm programs at both Reedley High School and Reedley Middle College. Parents inquired about expanding the farm programs to Orange Cove High School as well. These parents believe that expanding the farm and pathways would support students in their decision to pursue careers in agricultural fields. Parents expressed their appreciation for facilities projects and that they would like more classrooms to be built, especially with new construction happening in the KCUSD area. Parents also expressed a need for greater options for students at the middle school level in regards to electives. Parents also mentioned that they feel a need to expand the offerings that allow students to earn high school diplomas via independent studies and adult school for students who have fallen behind. Parents also expressed that many students, especially those from poverty, do not have access to the same resources and schools should ensure that they have access to technology, athletics, activities and academic and college field trips.

#### Teacher Groups:

Teachers were very supportive of the actions currently taking place through the previous LCAP and expressed that they would want all of these actions to continue. They specifically mentioned that the Expanded Learning Programs are a great addition to the schools but expressed that with the increase in staff, greater efforts must be made to provide additional professional development opportunities, especially to newer staff members. They provided suggestions on how to expand professional development, especially for new teachers across all grade levels. They also encouraged the expansion of intervention teachers and improved systems as to who receives intervention services. Teachers also requested an expansion of electives at the middle school level for the purposes of engagement opportunities. They also expressed that the additional classified staff on campuses has been a great service to students and should be expanded. It was also recommended that the CTE opportunities presented to students at the middle school should be reviewed and expanded to support greater CTE access for more students. Saturday Academy is a program that should definitely continue or be expanded.

### **Classified Groups:**

Classified staff was very pleased with additional supports provided through extended hours for classified staff. A lot of feedback was provided regarding supports to students who are struggling, especially at the continuation high schools and recommended adding supports and facilities to the program at Mountain View School to support improving graduation rates for students. They also made recommendations regarding additional special education supports to assist with helping students get onto school busses and having more time to help students during the day and requested additional bus routes, especially in the Reedley area. They also recommended adding more bilingual staff to support parent engagement and expressed that having a new parent engagement coordinator will be a great addition to our District. As new facilities have been built, classified staff requested additional custodians to help maintain and keep up facilities. Classified staff also appreciated the Parent University programs being offered in 2022-2023 and glad the professional development activities have increased for classified staff. They would like this to continue.

#### Administrators/Principals:

Administrators provided feedback on the LCAP following discussions with School Site Councils, ELAC's and other advisory councils. Feedback from administrators reflected the need to continue to provide additional electives for secondary students, tutoring opportunities and continued support for the implementation of instructional technology. Administrative feedback also included the need for greater communication regarding CTE offerings and continued support for college and career pathways. Credit recovery opportunities were also an area identified as needing attention for high school students that have fallen behind. Administrators also requested an expansion of the supports in place for English Learners such as EL acceleration programs, supports for newcomers and additional bilingual aide support in the classroom. District administrators also request the continuation of existing outside service to house curriculum materials to support the delivery of standards based instruction. Special Education Parent Connect and Special Education Cabinet

Parent Connect groups expressed that additional meetings for parents of students with disabilities should be held to support parents in connecting with other parents. Parents would also like greater communication with teachers on what is going on in schools to be able to support the academic and behavioral strategies at home. Parents expressed that the best way to connect with them is through direct phone calls.

#### Advisory Groups:

Feedback received from the District English Learner Advisory Committee and District Advisory Committee groups was very supportive of the actions being implemented by KCUSD. These groups, which are predominantly made up of parents, expressed that there was a great need for additional supports for struggling students, especially for social emotional needs. This includes additional SEL for students and antibullying support. It was requested that social workers be added to the elementary grades. Parents also requested an expansion of the supports in place to support special education students and students with behavior issues. Parents requested additional parent education specifically around navigating student information systems like PowerSchool and being able to navigate that system to be able to support their children from home. This year, there have been greater requests for parent training around social media and how to support the challenges posed by negative postings and social media pressures. Advisory groups also requested that the technology that is being utilized is adequately updated to keep up with changing technological requirements. Parents expressed their gratitude for parent workshops through Parent Academy, Children's Day and new in 2022-2023, Parent University through the partnership with Fresno State. Parents commented on how well structured and informative these programs are and would want to not only continue, but be expanded. These workshops should continue to include financial literacy. In order to address the limited number of parents that participate, it was requested that incentives be offered for parents who participate and make parent engagement opportunities more enjoyable. Parents expressed how grateful they are for the co/extracurricular activities that are available as many would not be able to afford or provide them otherwise. They requested that these activities be expanded at the elementary level. They also expressed gratitude for the availability of preschool as many families could otherwise not afford to enroll their children in programs if not available through the District. These advisory groups also advocated for the establishment of "Family Resource Centers" in both Orange Cove and Reedley as hubs to serve as student and family support centers. Advisory groups expressed interest in expanding current CTE pathways and providing alternatives to college while still helping students stay eligible for UC/CSU admission. It was discussed that there is a need to connect students to CTE opportunities in elementary school District wide. DELAC specifically requested transportation be included for Saturday Academy to increase participation and an expansion of the bilingual books available in libraries to promote biliteracy. Advisory groups, especially DELAC, expressed that additional resources are needed for newcomer English Learners as these students have greater and more immediate needs. Additional teacher support and professional development is needed to adequately support these students.

#### Student Groups:

Many expressed that they need more counseling opportunities and access to a wider range of elective courses to prepare for college and career opportunities. They also expressed the importance of relationships with their teachers while acknowledging that teachers and staff do their best to promote a positive climate and culture. Students overwhelmingly perceive that they are getting a good education through the educational programs established by their school sites.

#### A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The following actions were influenced by specific educational partner input and integrated into the LCAP:

Kings Canyon Unified School District's LCAP goals were originally developed through collaboration between all educational partners. KCUSD continues to seek input on the actions and goals of the LCAP to determine the best strategies to increase student achievement and grow the capacity of our system. Input from educational partners indicates that the current goals and actions have been effective and should continue with additional supports for students, staff and families.

Continued and new actions influenced by specific educational partner input are listed below:

### Goal 1:

The actions in Goal 1 are continued actions and educational partners were supportive of continuing these actions as they provide the majority of the District's basic services required for the operation of the District. Reflected in the spending under this goal includes expansion of facility, transportation and food service needs. Educational Partner input reflects appreciation of the facility improvements, especially those constructed for the purpose of improving health and safety as a result of the COVID-19 pandemic.

### Goal 2:

Educational partner input indicated that KCUSD should continue to support teachers and classified staff through professional development. This is included in this goal. Specifically, actions 2.2 (2.7 (Instructional Coaches), 2.15 (NGSS Support) and 2.19 (Supplemental Professional Development) support this need for expanded targeted and job embedded professional development. Feedback regarding the importance of preschool supported the expansion of preschool staff (2.11). The expansion of action 2.21, targeting the mitigation of potential overidentification in special education was influenced through input from staff, parents and administrators in being able to provide additional supports for struggling students. As an additional support, the inclusion of action 2.22 (Intervention Teachers) and 2.14 (Instructional Resources) directly addresses the need to provide additional intervention and resources in support of students at risk of falling behind grade level. Parents expressed the need to continue to expand field trips and co/extra curricular activities, resulting in a planned return of Sci-Con in 2022-2023 (2.20) and additional study trips across the District.

### Goal 3:

English Learners make up approximately 27% of the students in the District. Educational partner input shows that KCUSD has done an outstanding job supporting the needs of EL students and working towards reclassification. Through this feedback, the actions in Goal 3 will continue with the intention of increasing the use of additional progress monitoring tools. Through DELAC input, KCUSD has included action 3.5 (Promoting Biliteracy and Cultural Awareness) to increase awareness of the benefits of biliteracy in support of emerging bilinguals and the District's Dual Immersion program at Alta Elementary. Action 3.6 was also expanded to include a Fall Saturday Language Academy and to provide transportation based on parent input. KCUSD's Migrant program has been included in this goal in response to feedback received indicating that the majority of students in the Migrant program under action 3.10 are also English Learner students. Additionally, parents and administrators have expressed the need for additional supports for English learners. KCUSD has hired two additional teachers on special assignment to focus on addressing the needs of English learners (3.11).

#### Goal 4:

Traditionally, of the most frequently mentioned feedback points from all educational partners is the importance of Career Technical Education opportunities for students in KCUSD. Unfortunately, it is not currently feasible to replicate all pathways across all high schools, feedback was influential in the expansion and supporting of current CTE programs in KCUSD. Actions 4.1 (College and Career Guidance and Support), 4.2 (Career Technical Education Support), 4.4 (K-8 College and Career Readiness), and 4.13 (VROP) all provide for the promotion and expansion of the CTE programs in the District. Input from students showed that KCUSD would do well to expand the marketing and promotion of CTE pathways, especially with elementary students. Action 4.10 (Summer Extended Learning) was written with feedback from educational partners in mind. A major point of feedback was that in the central valley of California, agriculture is an important part of the local economy. Many of our students, especially those from low income families stand to benefit from expansion of the agriculture pathways currently in place in KCUSD. As a result of this feedback, Action 4.18 was created to allow for an expansion of this CTE opportunity for students.

#### Goal 5:

Educational partner input as well as student and parent survey results show that the actions in this goal around climate, culture and school safety and connectedness have been successful and should continue. Specific feedback from parents, staff and students, point to specific actions for this success. KCUSD's Expanded Learning Program (action 5.4) was mentioned as critical to student success. KCUSD will continue and expand this service. Educational partner feedback also indicated that the structures in place through the successful implementation of Positive Behavior Intervention and Support programs at all sites (action 5.1 and 5.3) has resulted in positive outcomes for students. Parents have expressed that additional supervision would make students feel more safe. As a result of this feedback, additional campus assistants will be added to the K-5 campuses in 2023-2024 (Expansion of 5.3). Considerable educational partner input was received addressing the need to expand the social-emotional supports available to students. In response to this feedback, KCUSD will expand the number of Social Workers, MFT's and On-Site Counseling (action 5.7), and Behavior Intervention team members and School Psychologists (5.8) in the 2023-2024 school year. Additionally, KCUSD will be expanding the explicit instruction of Social Emotional Learning in support of students social emotional well-being and expand professional development of staff with Trauma Informed training. A continued action in response to feedback received to address the need for supports for students with behavior challenges is the Restorative Justice Program (action 5.11). This action will allow KCUSD to build on the partnership it has launched with the City of Reedley to support students when behavioral infractions do occur. Families have continuously expressed the need for additional centralized services. Currently, families receiving Migrant Program services must go to the Grant Middle School campus. Students working with the Restorative Justice team must walk onto a campus that they do not attend. Foster and Homeless students do not have a centralized location to inquire about services. Based on this feedback, KCUSD will be establishing a Family and Student Support Center which will serve as a hub for parents to receive services and connect with service providers.

#### Goal 6:

Educational partners (parents specifically) provided feedback on the increased effectiveness of District and site communication, especially throughout the COVID-19 pandemic. As a result of this feedback, actions 6.6 (District and School Websites), 6.8 (Unified Communication System), 6.11 (School to Home Communication Team), 6.12 (Parent Engagement Team) were included. As a result of the addition of Parent Square, parents as well as school staff expressed improvement in two way communication and effectiveness of communication through

digital/text platforms. Parents also expressed appreciation of site Parent Academy and Puente a Tecnologia programs (actions 6.3, 6.9 and 6.13) and school and District parent engagement opportunities such as Children's Day (6.10) and Parent University.

Through continued input and feedback received, KCUSD will adjust its action plan as needed to support increasing student achievement, supporting parents and growing the capacity of all staff in KCUSD.

Goal 1 has been developed for the purpose of addressing state priorities 1 (Basic Conditions of Learning) and 2 (State Standards-Conditions of Learning). It is a priority of Kings Canyon Unified School District that students have basic services, ensuring that all students are attending school on campuses that are in good condition while being taught by teachers who are appropriately assigned and provided with adequate textbooks, materials, supplies and supports. It is the philosophy of KCUSD that by ensuring all of these basic conditions of learning, students will be in the best place to achieve their highest potential. Through effective professional development, strategic planning and efficient use of resources, students and staff will have the resources needed to continue to improve outcomes for students. KCUSD has seen consistent growth since 2015 across all indicators on the CA School Dashboard and expect to continue this growth.

The actions outlined in Goal 1 supported the progress toward meeting the goal.

Action 1.1 - Credentialed Teachers Implementation Status: 5 – Full Implementation KCUSD has established ongoing HR practices, including procedures for hiring and recruitment, leading to qualified staff. KCUSD is always looking to improve recruitment and retainment and utilizes partnerships with local universities, and credentialing programs to recruit the teachers possible.

Action 1.2 - Basic Operating Expenses, Action 1.3 - Provide and Maintain Facilities, Action 1.4 - Transportation Implementation Status: Full Implementation and Sustainability KCUSD continues to effectively operate all schools and maintains basic operating expenses, maintenance of facilities and transportation for students.

Action 1.5 - Guidance and Learning Center - Special Education Implementation Status: Full Implementation and Sustainability KCUSD continues to fund the Special Education services required to provide students with disabilities.

Action 1.6 - Site Base Allocations

Implementation Status: Full Implementation and Sustainability KCUSD continues to distribute site lottery allocations to all school sites.

Overall Successes: Overall success for Goal 1 is based on the ability to have fully operational and staffed school sites, support programs and a return of co and extracurricular activities in KCUSD. KCUSD has successfully utilized COVID relief funds together with prioritized funding to create safe, welcoming and supportive facilities for students, staff and families. New facilities were also built to increase safety for students and staff as well as continued improvements to HVAC units, lighting and general infrastructure. In 2022-2023, KCUSD also expanded the support available for socio-emotional support and for the purpose of mitigating any learning loss that may have occurred. KCUSD qualifies for Differentiated Assistance and has been proactive in increasing the support available for students with disabilities as well as improving support structures for all students, especially those in danger of falling behind and not graduating on time.

Overall Challenges: Perhaps the greatest challenge to implementing Goal 1 for KCUSD was the recruitment and retention of qualified staff to fill necessary positions. KCUSD has been able to recruit for open positions through partnerships with local universities and credentialing programs such as the Tulare County IMPACT program. KCUSD has been successful in filling positions, but this continues to be a great challenge. On the facilities front, rising costs continue to present challenges as projected projects often become more expensive than originally budgeted and adjustments must be made.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between planned and estimated actual expenditures for the following action:

Action 1.4: The estimated actual expenditure for action 1.3 was approximately 27% higher than planned expenditures. This was a result of an increased cost of fuel and the increase in student activity trips that were able to be conducted following the COVID-19 pandemic.

An explanation of why the LEA has developed this goal.

Goal 2 was developed to address state priorities 2 (State Standards), 4 (Pupil Achievement), 7 (Course Access), and 8 (Other Pupil Outcomes). It is a priority of Kings Canyon Unified School District that all students have access to grade-level state standards, along with rigorous curriculum to support academic achievement for all students. The continued actions outlined in Goal 2 have resulted in continued growth since 2015 in both ELA (15% increase in percentage of students meeting and exceeding standards) and Math (20% increase in percentage of students meeting and exceeding standards). Ultimately, if students in KCUSD continue to make progress on the metrics outlined in Goal 2, students will have a greater opportunity to pursue a greater range of options upon graduation from high school. The growth students in KCUSD have made is expected to continue as a result of continued implementation of this goal.

No substantive difference in planned action compared to the actual implementation. KCUSD continues to provide ongoing professional development to teachers and administrators on effective use of adopted materials.

Action 2.2 - Teacher Resources for Instruction

Implementation Status: Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. Teachers are trained on how to utilize the teacher resources to support the effective delivery of instruction and interventions.

Action 2.3 - Baseline VAPA and Physical Education Techs

Implementation Status: Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. Additional time allocated through action 2.25 has allowed more effective implementation of this action.

Action 2.4 - Additional Instructional Aides

Implementation Status: Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. Action was implemented as planned with additional positions being added in 2022-2023 in support of classroom instruction.

Action 2.5 - Transportation to Reduce Loss of Instructional Time

Implementation Status: 5 - Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. In order for our English Learners, foster youth, lowincome students to participate in athletics and maximize their time in the classroom KCUSD provided additional bus drivers to limit the amount of time students must leave their school site before dismissal time, thereby increasing instructional time and access to learning. Action 2.6 - System and Accountability Team

Implementation Status: Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. This team was expanded as planned in 2022-2023. No substantive difference in planned action compared to the actual implementation. The Educational Programs Department continues to support the monitoring of student achievement and implementation of the LCAP to sustain continuous improvement.

No substantive difference in planned action compared to the actual implementation. This action provided State Preschool Programs at Dunlap School, Washington Elementary, A.L. Conner Elementary, Silas Bartsch School, Jefferson Elementary, Lincoln Elementary, McCord Elementary and Great Western Elementary.

Action 2.12 - Technology Department

Implementation Status: Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. This action provided baseline technology supports for the purpose of increasing student achievement across KCUSD.

Action 2.13 - Supplemental Technology

Implementation Status: 5 – Full Implementation

No substantive difference in planned action compared to the actual implementation. This action supported the purchasing of additional computers to ensure 1:1 access in classrooms, computers that students can utilize at home when necessary, mobile hotspots to support students that do not have internet at home and additional instructional technology to support the delivery of instruction in classrooms.

Action 2.27 - Supplemental Library Services

No substantive difference in planned action compared to the actual implementation. This action allowed for students to continue their learning beyond the classroom and access to tools they would otherwise not have.

Overall Successes: Based on the 2021-2022 state assessments, KCUSD continues to score well, especially when compared to similar and neighboring districts. In comparison to surrounding districts, KCUSD has historically been among the higher achieving Districts in both Fresno and Tulare Counties. In 2022, KCUSD ranked third among all unified school districts in both Fresno and Tulare Counties for Percent Met or Exceeded in ELA and second in Math. When comparing average distance from standards, KCUSD ranked second among all unified school Districts in both counties in ELA and third in Math. More impressively, when comparing only school districts with similar demographics (Enrollment of over 1000+ and 80%+ economically disadvantaged students) KCUSD ranks one out of fifty - seven similar districts for the percentage of students meeting or exceeding standards and one out of fifty-seven similar districts for average distance from standard.

Overall Challenges: KCUSD will need to continue to improve outcomes for students with disabilities and foster youth. KCUSD has qualified for Differentiated Assistance and will continue to work alongside the Fresno County Superintendent of Schools office to examine strategies to improve the academic achievement of these student groups in addition to all students. While every student group showed growth across the metrics used to measure progress in this goal, KCUSD will continue to increase support for the students that are not yet at 100% meeting standards.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between planned and estimated actual expenditures for the following action:

Action 2.8: The estimated actual expenditure for action 2.8 was lower than planned expenditures. These funds were reserved to hire site level positions using 15% additional concentration dollars. These actions will be carried over to fill positions in 2023-2024. Additional

positions are intended to increase and improve services to support the work currently in place. This material difference did not impact the implementation of the existing program.

Action 2.10: The estimated actual expenditure for action 2.10 was lower than planned expenditures. This was due to construction for KC Kids was not completed in 2022-2023 and will be paid for in 2023-2024. This material difference did not impact the implementation of the existing program.

Action 2.13: The estimated actual expenditure for action 2.13 was lower than planned expenditures. This was a result of several vacancies not filled due to labor shortage. These positions will be filled in 2023-2024.

Action 2.14: The estimated actual expenditure for action 2.14 was lower than planned expenditures. These funds were reallocated to other adopted increased and improved actions where additional funding was needed to best support English Learners, Foster Youth and low-income students.

Action 2.15: The estimated actual expenditure for action 2.15 was lower than planned expenditures. This was a result of a consultant no longer being utilized to provide professional learning experiences. Consultant's duties were absorbed by instructional coaches, lead teachers and District administration. Material difference did not impact the implementation of the existing program.

Action 2.16: The estimated actual expenditure for action 2.16 was lower than planned expenditures. This was due to inability to hire qualified staff due to labor shortage. In order to reach full implementation and sustainability, KCUSD will need to continue to recruit and retain additional staff.

Action 2.19: The estimated actual expenditure for action 2.19 was higher than planned expenditures. This was a result of the increase to salaries and increased cost of services. Material difference did not impact the implementation of the existing program.

Action 2.20: The estimated actual expenditure for action 2.20 was lower than planned expenditures. This was a result of KCUSD being allowed to utilize a credit that was available due to not being able to participate during the pandemic. Material difference did not impact the implementation of the existing program.

Action 2.21: The estimated actual expenditure for action 2.21 was higher than planned expenditures. This was a result of increased salary and benefits for the staff hired in these positions. Material difference did not impact the implementation of the existing program.

Action 2.24: The estimated actual expenditure for action 2.24 was lower than planned expenditures. This was a result of one teacher being paid for out of EPA funds in 2022-2023. Material difference did not impact the implementation of the existing program.

Action 2.25: The estimated actual expenditure for action 2.25 was lower than planned expenditures. This was a result of vacancies throughout the year due to labor shortage. In order to reach full implementation and sustainability, KCUSD will need to continue to recruit and retain additional staff.

The metrics used to identify progress show that most student groups showed improvement on all metrics with the exception of English Learners in the percentage of 11th grade students

being considered conditionally ready/ready for college Mathematics and ELA. This percentage did decline in comparison to the 2020-2021 scores. Every other metric utilized showed growth across all student groups.

Action 2.16 was revised to better reflect the the focus on English Learners, low-income and foster youth students. This goal has been established to ensure that English Language Learners have increased support towards attaining English language proficiency and increasing student achievement on state and local measures. 27% of the students in Kings Canyon Unified are currently English learners with a majority of students in KCUSD having been English learners at some point in their educational experience. Because of this, it is critically important for KCUSD to continue to focus on the progress of English learners to support their acquisition of English proficiency. This goal is implemented in alignment with Goal 2. The growth English learners have made will continue through the implementation of this goal and will support their academic achievement.

No substantive difference in planned action compared to the actual implementation. The Migrant Program continues to support students in collaboration with FCSS. A new Migrant Program Coordinator was hired in 2022-2023 to support this work.

No substantive difference in planned action compared to the actual implementation. TSAs supported site teams with parent outreach, analysis of student progress data, and provided professional development to support the needs of English learners.

Action 3.12 - Supplemental Supports for Migrant Program

Implementation Status: 5 – Full Implementation and Sustainability

No substantive difference in planned action compared to the actual implementation. These continued supports allowed Migrant Program students to receive the supplemental support they needed to continue to increase academic achievement through coordination of community resources, college readiness, work study programs, data analysis and other support as necessary.

Overall Successes: Through the actions in Goal 3 working together to increase student achievement for English learners, KCUSD saw significant progress in closing gaps in learning that may have come about due to the impact of lost instructional time during the pandemic. Summative ELPAC data from 2022 shows students have made significant progress in closing gaps. District-wide, English learners showed a 7.3% increase in the number of students scoring proficient with 15.37% attaining a Level 4. This was reflected in the 3.4% increase of students reclassified compared to the 4% 2020- 2021 reclassification rate. In addition, 55% of the English learner population showed progress toward English language proficiency as measured by the ELPI. In ELA, English learners showed an increase of 10.1% in those students who met or exceeded standard on the 2022 SBA as compared to the 8.89 % who met or exceeded standard in 2021. Math showed similar growth with 16.55% of English learners meeting or exceeding standard on the 2022 SBA as compared to the 6.08% who met or exceeded standard in 2021. One of the most significant reasons for the success of this goal was the effective integration of work between the Migrant Program and English Learner Department teams and their coordination with the Curriculum and Instruction department.

Overall Challenges: While there has been significant student achievement growth for English learners overall in the areas of English language proficiency, ELA and math as measured by the ELPAC and Smarter Balanced assessments, 11th grade students in this group did not show growth. When comparing student achievement data from the 2021 SBA and the 2022 SBA, English learners showed a 1.69% decrease in the percentage of students meeting or exceeding standard in ELA, and a 5.51% decrease in math. Subsequently, 11th grade English learners as a group are not considered conditionally college and career ready. In addition, 15.1% of English decreased at least one level on the ELPAC. One of the greatest challenges to implementing this goal has been utilizing all of the many data sources to concisely pinpoint student areas of need. Through continued collaboration, these tools will eventually allow for more effective identification of student learning gaps.

There was a material difference between planned and estimated actual expenditures for the following actions:

Action 3.2: The estimated actual expenditure for action 3.2 was lower than planned expenditures. This was a result of the ELD Coach position not being hired in 2022-2023. ELD Coach position is planned to be recontinued in 2023-2024.

Action 3.3: The estimated actual expenditure for action 3.3 was lower than planned expenditures. This was a result of several consultants not being utilized in 2022-2023.

Action 3.6: The estimated actual expenditure for action 3.6 was lower than planned expenditures. This was a result of a two year contract not being paid for in 2022-2023. These funds will be carried over to pay for next year's costs in support of interventions.

Action 3.8: The estimated actual expenditure for action 3.8 was lower than planned expenditures. This was a result of fewer materials and supplies being required in 2022-2023.

The actions outlined in Goal 4 supported the progress toward meeting the goal.

Action 4.1 - College and Career Guidance and Support Implementation Status: 5 – Full Implementation and Sustainability KCUSD continues to support college and career readiness through counseling and guidance including career advisors and transition teams.

Action 4.2 - Career Technical Education Support

Implementation Status: 5 – Full Implementation and Sustainability

KCUSD continued to provide a wide range of CTE programs and pathways across the district. Students in these programs were able to utilize industry standard equipment, observe multiple career pathways, visit vocational education programs, gain professional development, develop CTE skills and visit college and university programs.

Action 4.3 - K-8 College and Career Readiness and Awareness Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to provide services targeted for English learners, low-income, and foster youth students to support college and career readiness and awareness through college preparation guidance, A-G requirements workshops, tutorial support and mentoring.

Action 4.4 - Co-Curricular Activities

Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to provide elementary, middle and high school athletics, NJROTC, secondary music, art and drama programs and co/extra curricular activities.

Action 4.5 - Supplemental Athletic Resources Implementation Status: 5 – Full Implementation and Sustainability This action continued to provide transportation for and materials needed to ensure athletic opportunities are available to low-income students, while minimizing time lost from instruction.

Action 4.6 - Performing Arts Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to offer VAPA across the district from elementary to high school.

Action 4.7 - GATE Program

Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to provide early exposure to accelerated learning experiences and supplemental instructional opportunities for low-income, English learners, and foster youth students through the purchasing of supplemental materials and enrichment activities.

Action 4.8 - Increased Supports for VAPA Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to provide support for VAPA across the district. Students participated in KC Showcase, art exhibitions, Oral Interpretation Festival, Peach Blossom Festival, attended local theater events, and participated in many performances.

Action 4.9 - Summer Extended Learning

Implementation Status: 5 – Full Implementation and Sustainability

KCUSD once again conducted a summer learning program to extend learning opportunities to District students as well as provide opportunities to recover credits, enjoy enrichment activities, interventions and remediation.

Action 4.10 - Student Transition Programs

Implementation Status: 5 – Full Implementation and Sustainability

Student Transition Program was extended in 2022-2023 to include greater transitions staff to support middle school student in addition to the work being done at the high school level.

Action 4.11 - School Connections Counselor

Implementation Status: 5 – Full Implementation and Sustainability School connections Counselor continued to work with students at the high level with an emphasis on Foster/Homeless Youth and students with disabilities. This program was expanded in 2022-2023.

Action 4.12 - Health and Nutrition Fitness Program Implementation Status: 5 – Full Implementation and Sustainability KCUSD expanded this program in 2022-2023 and has fully implemented this program at both Reedley High School and Orange Cove High School.

Action 4.13 - CTE Support - VROP Implementation Status: 5 – Full Implementation and Sustainability KCUSD continued to partner with Valley ROP to provide additional Career Technical Education pathways for middle school and high school students.

Action 4.14 - Native American Education Enrichment Program Implementation Status: Initial Implementation KCUSD provided workshops to support Native American educational enrichment programs culminating in a college visitation to CSU Fresno. This program will be expanded in 2023-2024.

Action 4.15 - College and Career Head Counselor Implementation Status: 5 – Full Implementation and Sustainability College and Career Coordinator was added in 2022-2023. This action has resulted greater consistency across KCUSD in regards to course work, monitoring and systems in place to support college and career readiness.

Action 4.16 - Additional Support for Mountain View School

Implementation Status: 3 - Initial Implementation

Mountain View School's support services are in the process of being reimagined to include greater in-person support, greater engagement opportunities and additional credit recovery opportunities available for students.

[This action was not fully implemented due to delay in facility completion. Mountain View School was successful in funding a full time administrator and beginning the construction of additional facilities. Mountain View School will compete the facility expansion in August 2023 and hire additional teachers necessary to better serve our students.]

Overall Successes: Through the work outlined in Goal 4, the greatest success is the increase in the graduation rate following a dip during the COVID-19 pandemic. Through the additional engagement and SEL supports, students are able to stay on track to graduate. Additionally, the many options presented through Educational Options programs and increase student support services such as the College and Career Counselor, Transition Program and extended year opportunities, more students are able to recover credits towards graduation. Another great success has been the expansion of many CTE programs, which will continue to expand in 2023-2024.

Overall Challenges: There was a slight decline in the percentage of students who are A-G eligible and in turn, the percentage of students who are A-G eligible who are also CTE completers. This in part is due to the impact of the COVID-19 pandemic and students still attempting to make up classes. This is a major priority moving in to 2023-2024.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between planned and estimated actual expenditures for the following actions:

Action 4.8: The estimated actual expenditure for action 4.8 was higher than planned expenditures. This was a result of the need to purchase several large musical instruments for the band program.

Action 4.9: The estimated actual expenditure for action 4.9 was higher than planned expenditures. This was a result of more students participating in the summer extended learning program enrichment activities.

Action 5.8 - K-5 Counseling Services Implementation Status: 5 – Full Implementation and Sustainability KCUSD contracted with Fresno Pacific's On-Site counseling to deliver counseling services to students at K-5 schools. In 2023-2024, plans are in place to hire additional counselors in support of providing additional services in K-5 schools.

Action 5.9 - Behavior Intervention Team and Psychologists

Implementation Status: 5 – Full Implementation and Sustainability

KCUSD increased the social emotional support for students as well as supporting the needs of the identified students and teachers through behavior interventions so both students and teachers have the tools necessary to respond to behaviors through restorative chats, equipping students with skills to avoid negative behaviors, and skill coaching.

Action 5.10 - Bronco Academy District Behavior Support Program Implementation Status: KCUSD will no longer operate this program in 2023-2024. The support established through this action will continue as part of the Behavior Intervention Team (Action 5.9) in 2023-2024.

Action 5.11 - School Based Health Center Health Coordinator Implementation Status: 5 – Full Implementation and Sustainability

KCUSD increased access to health services through a health coordinator who serves as a liaison between KCUSD and Adventist Health Jefferson School-Based Health Center to support the delivery of health services for low-income students to mitigate students missing school as a result of not having adequate health services. This action has been successful in connecting low-income students with reliable and affordable health care.

Action 5.12 - Supplemental Health Services

Implementation Status: 5 – Full Implementation and Sustainability

These increased services allowed for greater opportunity for students to be seen by medical professionals during the school day and provide referrals to specialists when needed, resulting in greater health intervention for low-income students.

Action 5.13 - Restorative Justice Program

Implementation Status: 5 – Full Implementation and Sustainability

KCUSD Restorative Justice counselors worked with students to take ownership of their actions while repairing relationships and building a stronger campus culture.

Action 5.14 -Additional Learning Directors

Implementation Status: Full Implementation and Sustainability

The additional support allowed school sites to focus on the greatest needs of students to mitigate behaviors that lead to suspensions and provide better supports for students and families.

Action 5.15 - Medi-Cal Reinvestment

Implementation Status: Full Implementation and Sustainability Medi-Cal funds generated through Medi-Cal and LEA Billing Option Program are reinvested in supports for students in support of this goal. Overall Successes: Attendance has begun to recover from the previous years and as a result, more students are able to benefit from the many socio-emotional supports that have been put in place. The expansion of the Behavior Intervention Team, additional Social Workers, psychologists, counselors and additional staff have all been able to support students directly on campuses. With improved monitoring tools and concentrated professional development on socio-emotional supports, students are able to receive greater levels of support in school.

Overall Challenges: Suspensions are slightly higher than in previous years. Additional socio-emotional supports have been put in place to support this slight increase in suspensions. Many students spent the previous two years in distance learning environments and had difficulty adjusting to full time, in person instruction. Teachers, classified staff and clinicians continue to provide the necessary supports to have students adjust to in person instruction and provide the support necessary to help students be successful.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between planned and estimated actual expenditures for the following action:

Action 5.3: The estimated actual expenditure for action 5.3 was higher than planned expenditures. This was a result due to the continuation of the daytime mentoring support provided by CYM to increase student engagement and assistance.

Action 5.4: The estimated actual expenditure for action 5.4 was approximately lower than planned expenditures. This was a result of KCUSD utilizing ELOP funds to support the after school Expanded Learning Programs in the District.

Action 5.10: The estimated actual expenditure for action 5.10 was approximately lower than planned expenditures. This was a result of the Bronco Academy being discontinued after January 2023.

Action 5.15: The estimated actual expenditure for action 5.15 was lower than planned expenditures. Remaining funds will be carried over to be reinvested in 2023-2024 to support student health and wellness activities.

An explanation of how effective the specific actions were in making progress toward the goal.

The LEA used the following rating scale to determine the effectiveness of the actions to achieve the articulated goal. Ratings were based on an analysis of both inputs from educational partners and metrics. Rating Scale (lowest to highest): 1 – Not Effective; 2 – Somewhat Effective; 3 –Effective.

The actions outlined in Goal One helped make progress towards the LEA's goal: Action(s): 5.1, 5.2, 5.3, 5.5 and 5.13 Effectiveness of Action(s): Effective Metric(s): Attendance rates, Chronic absenteeism rates (K-12), %age of students feeling safe at school as reported on the Annual Student Survey, %age of parents who rate "how effective personnel on this campus are in providing a safe and orderly environment for your child" in the affirmative on the annual parent survey.

Analysis Statement: These actions directly support efforts to create a safe campus with a positive climate and culture. Data from 2021-2022 show that while suspensions were higher compared to 2020-2021 data which were significantly impacted by the COVID pandemic, suspension data is lower than data from 2018-2019. The uniform expectation that PBIS is implemented across the District has contributed to these improvements over time. Since student's return to on-campus instruction, PBIS structures, social emotional learning opportunities and increased supports such as restorative justice programs and attendance supports have resulted in continued growth in positive climate and culture in KCUSD schools.

These actions deliver additional supports to students during the day that support positive climates and culture by supporting safety, connectedness and acceptance. The additional staff are able to provide more effective supervision and implementation of PBIS and are able to provide Tier 2 and 3 interventions for behavioral needs.

Action(s): 5.11, 5.12 and 5.15 Effectiveness of Action(s): Effective Metric(s): Attendance rates, Chronic absenteeism rates (K-12), Analysis Statement: These actions focus on the implementation of Health services and supports for the students of KCUSD to support increased attendance and decreasing chronic absenteeism. Through these supports, KCUSD was able to demonstrate markedly better chronic absenteeism data on the CA School Dashboard.

This has expanded to include annual state assessment reporting and in support of English Learner reporting.

Action 6.2 - Parent Survey

Implementation Status: Full Implementation and Sustainability

Parent Survey is administered annually and is routinely revised to ensure the district receives valuable parent input on programs, conditions and overall satisfaction and areas to improve.

Action 6.3 - Parent Academy Implementation Status: Full Implementation Every school site Every school site operates a Parent Academy program. Additionally, in 2022-2023, KCUSD partnered with CSU Fresno's Parent University to bring additional parent education courses.

Action 6.4 - Bilingual Community Aides

Implementation Status: Full Implementation and Sustainability

For the first time, Bilingual Community Aides are at every school site in KCUSD. This program was expanded to ensure every school site had a bilingual staff member in the office to serve as a liaison with families and serve as a champion for parent engagement and involvement.

Action 6.5 - Family Connection Techs Implementation Status: 5 – Full Implementation and Sustainability KCUSD continues to utilize Family Connection Techs to support English Learner students and their families. Action 6.6 - District and School Websites

Implementation Status: Full Implementation

KCUSD's websites have been redesigned in the past two years to create more user-friendly web spaces for parents to actively seek information and stay up to date on events pertaining to both the District and individual school sites. Feedback from families is that the new design is a great improvement from previous web sites.

Action 6.7 - School Based Health Center Outreach

Implementation Status: Full Implementation and Sustainability

KCUSD continues to partner with Adventist Health on the School Based Health Center located on the campus of Jefferson Elementary. This relationship has served the students and families of KCUSD consistently for over a decade.

Action 6.8 - Unified Communication System

Implementation Status: Full Implementation and Sustainability

The ParentSquare platform has improved communication from both school to home and from home to school by allowing two way communication and supporting primary language preferences. Additionally, it has created a single platform across the District so parents do not have to learn to navigate multiple platforms to communicate with school sites or the District office.

Action 6.9 - Puente a Tecnologia for Parents

Implementation Status: 5 - Full Implementation and Sustainability

Puente a Tecnologia continues to be an effective way to connect students and parents with technology and provide guidance on how to conduct research, access curriculum resources, enhance parent involvement, complete classroom assignments and build communication skills.

Action 6.10 - Children's Day Parent Program

Implementation Status: Full Implementation and Sustainability

KCUSD has continued the tradition of the annual Children's Day Celebration, celebrated on April 27, 2023 at Orange Cove High School with multicultural celebrations, student performances, connections with community partners and resources for families and a student recognition ceremony.

Action 6.11 - School to Home Communication Team Implementation Status: Exploration and Research Phase In 2023-2024, this team has not been in place. Recruiting for qualified staff is in process with expectations for the program to be fully implemented in 2023-2024.

Action 6.12 - Parent Engagement Team Implementation Status: Full Implementation and Sustainability KCUSD KCUSD utilized a principal on special assignment to implement the strategies and goals of this action. Together with the Bilingual Community Aides and site leaders, this team has been successful in increasing parent participation at baseline DELAC and DAC meetings, annual Parent Academy programs and increased engagement through the CSU Fresno Parent University program.

Action 6.13 - Site Parent Engagement Support Implementation Status: 5 – Full Implementation and Sustainability Individual school sites continue to implement their own site specific Parent Academy programs together with the CSU Fresno Parent University program. School sites operate a minimum of ten parent engagement opportunities per year, but most sites offer a greater number

than ten.

Action 6.14 - District Fair Implementation Status: N/A The District Fair did not take place in 2022-2023 so as to not take away from the Children's Day event.

Overall Successes: Overall, KCUSD's Parent Engagement and Involvement improved in 2022-2023 as evidenced by parent surveys and feedback received through the educational partner engagement process. Programs like the CSU Fresno Parent University, Puente a Tecnologia, Children's Day and expanded Bilingual Community Aide site supports have been successful. KCUSD will leverage the success from this school year and grow these programs in 2023-2024 to include more parents and use feedback to provide the most relevant parent education possible. The communication systems for parents in KCUSD continue to receive favorable reviews.

Overall Challenges: While parent engagement and participation continues to improve, it is a challenge to get a large number of parents to participate in the activities that are made available. KCUSD will continue to refine its programs to connect with what matters most to parents through the gathering of input from parents to provide the most relevant and meaningful workshops possible.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There was a material difference between planned and estimated actual expenditures for the following actions:

Action 6.1: The estimated actual expenditure for action 6.1 was lower than planned expenditures. This was a result of lower cost of the program

Action 6.3: The estimated actual expenditure for action 6.3 was approximately lower than planned expenditures. This was due to the Community Learning Hub in Orange Cove not being completed in 2022-2023. Funds will be carried over to support the establishment of that resource center in 2023-2024.

Action 6.6 and 6.8: The estimated actual expenditure for actions 6.6 and 6.8 were lower than planned because COVID relief funds were utilized to pay for these services.

Action 6.7: The estimated actual expenditure for action 6.7 was lower than planned expenditures. This was a result of an error in recording the salary of the Health Center Coordinator (Funded in Action 5.11) and expenses associated with this action paid for through LEA Billing Option Program.

Action 6.9: The estimated actual expenditure for action 6.9 was lower than planned because no new devices were needed in 2022-2023. These funds will be carried over to support a "refresh" of Puente Program devices in 2023-2034.

Action 6.11: The estimated actual expenditure for action 6.11 was lower than planned expenditures. This was a result of not filling the School to Home Communication Team in 2022-2023 due to not having sufficient qualified candidates.

Action 6.14: The estimated actual expenditure for action 6.14 was not expended. This action was not continued in 2022-2023.

An explanation of how effective the specific actions were in making progress toward the goal.

The LEA used the following rating scale to determine the effectiveness of the actions to achieve the articulated goal. Ratings were based on an analysis of both inputs from educational partners and metrics.

Through feedback received through both the annual parent survey and through a variety of advisory groups, parents felt that the efforts made by the District were successful and greatly appreciated. 97.4% of parent's surveyed felt that the District and school sites do a satisfactory job of keeping parents informed about events and news happening.

Analysis Statement: These action work together to provide support staff that can support the needs of our parents at both the school site and at the district level. The absence of the School to Home Communication team has made communication with families a greater responsibility for school sites.

Action 6.1 was previously a non-contributing action. It is now a contributing action. Action 6.14 was eliminated for 2023-2024 as it duplicated activities presented through the Children's Day activity.
