WHEREAS, California Education Code 37220 (a) (2), designates the third Monday in January (January 15, 2024) as "Martin Luther King, Jr. Day" and requires that all public schools and educational institutions throughout the state, on the first school day before or after the holiday occurs, hold suitable exercises commemorating and directing attention to the history of civil rights movement in the United States, and particularly the role therein of the Reverend Dr. Martin Luther King, Jr.; and

WHEREAS, Fresno County Superintendent of Schools joins the countywide attempt to pay tribute to the 2024 celebration of the Reverend Dr. Martin Luther King, Jr.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools acknowledge the significance of the holiday and encourage all Fresno County School Districts, in observance of Martin Luther King, Jr. Day, to participate in appropriate activities utilizing available curriculum and speakers that teach about contributions Dr. King made to his country and to its entire people and encourage all Fresno County School Districts to participate with appropriate activities and curriculum on this day and throughout the year.
