WHEREAS, in a research survey approximately 50% of Sikh American students are bullied at school; and

WHEREAS, the negative consequences of bullying are significant, in extreme cases leading to suicide by young victims; and

WHEREAS, FCSS recognizes that bullying in school and among school age children is a serious problem throughout the country and often has serious lasting consequences; and

WHEREAS, FCSS supports evidence based anti-bullying initiatives

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools do hereby recognize the observance of "Anti-bullying Toward Sikh Americans" Month to educate students on the consequences of bullying and teach victims as well as perpetrators through positive anti-bullying intervention.
