WHEREAS, the Fresno County Superintendent of Schools ("FCSS") and Fresno County Board of Education ("FCBE") have determined that school facilities operated by the FCSS within Fresno County periodically need to be constructed or modernized; and

WHEREAS, the State Allocation Board ("SAB") has established an Applications Received Beyond Bond Authority List; and

WHEREAS, applications received by the SAB for programs without sufficient bond authority are placed on the Applications Received Beyond Bond Authority List.

NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Education and the Fresno County Superintendent of Schools pursuant to Title 2, Code of California Regulations Section 1859.95.1, hereby acknowledges the following:

- (1) the FCSS and FCBE acknowledge that the remaining School Facility Program bond authority is currently exhausted for the funds being requested on this(these) application(s).
- (2) the FCSS and FCBE acknowledge that the State of California is not expected nor obligated to provide funding for the project(s) and the acceptance of the application(s) does not provide a guarantee of future State funding.
- (3) the FCSS and FCBE acknowledge that any potential future State bond measures for the School Facility Program may not provide funds for the application(s) being submitted.
- (4) the FCSS and FCBE acknowledge that criteria (including, but not limited to, funding, qualifications, and eligibility) under a future State school facilities program may be substantially different than the current School Facility Program. The FCSS's Approved Application(s) may be returned.
- (5) the FCSS and FCBE acknowledge that they are electing to commence any pre-construction or construction activities at their discretion and that the State is not responsible for any pre-construction or construction activities.
- (6) the FCSS and FCBE acknowledge that, if bond authority becomes available for the SAB to provide funding for any application(s) submitted under financial hardship status, the FCSS must apply for financial hardship status at the time the application is processed.
