Crescent View West Public Charter Renewal
Petition

RESOLUTION NO. 2026 - 23

WHEREAS, pursuant to Education Code ("EC") sections 47605 and 47607, the Fresno County Board of Education ("County Board"), on April 23, 2026, received a renewal charter petition ("Renewal Petition") seeking a five-year term beginning July 1, 2027 and ending June 30, 2032, for the Crescent View West Public Charter School ("CVWPC"); and

WHEREAS, CVWPC is currently authorized pursuant to a charter that had previously been granted by the County Board for the term of July 1, 2021 through June 30, 2026 which term was subsequently extended by law, pursuant to EC section 47607.4, through June 30, 2027; and

WHEREAS, CVWPC is designated as a Dashboard Alternative School Status ("DASS") school; and

WHEREAS, a committee ("Charter Committee") reviewed the Renewal Petition pursuant to the applicable criteria established in EC sections 47605, 47607, and other applicable statutes and regulations; and

WHEREAS, a public hearing on the Renewal Petition was conducted on June 18, 2026 at which time the County Board received and considered the level of support for the Renewal Petition; and

WHEREAS, the Charter Committee reviewed the Renewal Petition and submitted for the County Board's consideration a Committee Report regarding the Renewal Petition dated July 1, 2026 ("Committee Report"), which is attached hereto, in which the Charter Committee recommends approval of the Renewal Petition; and

WHEREAS, the County Board has reviewed the Renewal Petition, including the supporting documentation and information; considered applicable law and regulations; and reviewed and considered the Committee Report, including analysis and recommendation; and

WHEREAS, based on the criteria set forth in EC sections 47605, 47607, and other applicable law and regulations, the County Board has done the following: (1) Considered CVWPC's performance and performance of all subgroups of pupils served by CVWPC on the state and local indicators included in the evaluation rubrics adopted pursuant to EC section 52064.5; (2) Considered CVWPC's performance on alternative metrics applicable to CVWPC based on the pupil population served pursuant to EC section 47607(c)(7); (3) Reviewed all required data pursuant to EC 47607; and (4) evaluated whether CVWPC has complied with the criteria set forth in EC 47605 and 47607.

NOW, THEREFORE, BE IT RESOLVED by the Fresno County Board of Education as follows:

1. The County Board finds the above-listed recitals to be true and correct and incorporates them herein by this reference.
2. The County Board hereby adopts the attached Committee Report which is incorporated herein in its entirety by this reference.
3. The County Board, having reviewed and considered the Renewal Petition, supporting documentation and applicable data, applicable EC sections, other applicable laws and regulations, the applicable criteria, and the Committee Report, hereby approves the Renewal Petition for a term of five years (July 1, 2027 through June 30, 2032):
4. The County Board's approval of the Renewal Petition is conditioned upon CVWPC entering into a memorandum of understanding with the County Board within 30 days setting forth the terms and conditions governing CVWPC's operation and program.

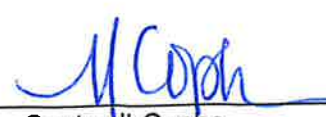
